Fran reported on the meeting with the Women's Committee of Local 199.

Edith is putting out a letter to UAW Council delegates and Local Union officers re. child care needs.

Sue reported on the meeting with Marian Boyd. Child care staff will come to the Centre and use our facilities.

> 0 - 18 months - 3 infants per one staff 18 months to age 10 - 5 children to one staff \$5 to \$6.50 per hour paid to child care workers Ouote of infants to 14 \$25 per day per child for infant care includes 14 hours of care per day.

They carry insurance of \$5 million - a minimum of 5 children to a maximum of 25. They would use the camp nursery. In Toronto, we would have to rent a room.

Ray reported the nursery facilities in the camp meet legislation requirements and insurance coverage is included.

John Firth reported one week's notice would be required.

Wendy reported that NDP use Umbrella Inc.

John Firth reported that Marian was very pleased with the nursery but we may have to purchase play pens.

Jim Maxell was concerned about delegates bringing their children and taking space adults pay for at Canadian Council.

Gord felt a policy should be brought forth to the Council covering child care by the Women's Committee for approval.

## 1. Age

Infants to 14 years on weekend conferences, Women's Conference, leaders ship and other similar annual activities

2. Cut-off date for child chare will coincide with cut off date for delegates or two weeks prior to the conference for Canadian Council with all local unions taking full responsibility for arranging with their delegates if child care is needed and to forward such information to the Secretary-Treasurer of the Council.

## Cost

The Council to pick up cost of child care for Council meetings until June of 1982. Registration fees on all other conferences will include day care costs.
