QUESTION & ANSWER ABOUT IMMIGRATION

Q. Is the new FDM now in force?

When the Immigration Minister announced changes to the FDM on January 30, 1992, he also announced a 12-week moratorium during which instructions on the new FDM would be written and no processing of new applicants to the FDM would be done abroad for the 12-week period.

Q. What can we do to prevent the government from going ahead with the new eligibility criteria, i.e. Grade 12 or equivalent and 6 months full time training?

Write to Hon. Bernard Valcourt, Minister of Employment and Immigration in Ottawa and say what you think about these new criteria.

Ask your friends, your employer, others to write their own members of Parliament if they oppose these changes. It takes a lot of letters and plenty of action to oppose government policies and change them.

Q. When I file my application for permanent residence I know I should pay a processing fee of \$350. Should I also pay additional fees for my husband and two children whose names are included in my application form?

PARLIAMENT MEMBERS HEAR DOMESTIC WORKERS OPPOSE NEW FDM CRITERIA

In a hearing of the House of Commons Standing Committee on Labour, Employment and Immigration, representatives of domestic workers organizations called for the withdrawal of new criteria for admitting women to the Foreign Domestic program (FDM).

Spokespersons of INTERCEDE, West Coast Domestic Workers Association (Vancouver), Association for the Defence of Domestic Workers' Rights (Montreal) and Coalition of concerned Groups for Foreign Domestic Workers (Montreal) told members of parliament that the requirements of a Grade 12 or equivalent education and six months full-time training in related live-in care that were announced by Immigration Minister Bernard Valcourt on January 30 will worsen discrimination in the FDM against women of colour.

Instead, they all called for granting permanent residence status to foreign domestic workers and eliminating the system of temporary work permit. They also called for an end to the mandatory live-in requirement.

On the other hand, representatives from the Ministry of Immigration and from the Coalition for In-Home Child and Domestic Care justified the new education criteria as making domestic workers employable in the labour market.

INCOME TAX RETURNS.

BRING a tax return form, your T4, etc.

You can get blank tax return forms from a Revenue Canada Taxation office or post office or a library near you.

INTERCEDE counselling and CLASP Legal Clinic will be available.

2-3 pm - Member application and renewals will be processed. Members in 1991 with I.D. no. <u>1314</u> to 1503 must renew or be dropped from list of members.

You only pay the processing fee of \$350 for yourself. In the future, when you are already a landed immigrant you can sponsor your family if you meet the requirements for sponsorship. At that time you will pay their processing fees.

Q. How come I have been asked to pay another \$250 by Immigration in addition to the \$350 fee I paid when I filed my application for permanent residence?

We have been informed that Immigration will charge \$250 more at a later date, in addition to the \$350 processing fee when foreign domestic workers file their application for permanent residence. On September 1, 1991, this additional amount was introduced to the Immigration Act Fees Regulations. This fee is for Order-In-Council Requests that used to be free.

An Order-In-Council request is for special authority from the Governor in Council to allow processing of an application for permanent residence from within Canada and to overcome other legal requirements.

INTERCEDE considers that Immigration fees charged to domestic workers in the FDM are exorbitant in relation to the minimum wages they receive. INTERCEDE has complained against hikes in Immigration fees for employment authorization

Among the questions asked by a Member of Parliament in the Committee was how a required level of education like Grade 12 assures that someone will be better able to take care of children, "to fold sheets, to iron, to wash the baby's fanny?" In her remarks, Lorina Serafico of the West Coast Domestic workers Association noted that "in British Columbia our former two premiers before the present one were not required to have a grade 12 education to do their job - to run a province."

As a result of the many problems raised by domestic workers in the February 26 presentations, members of the House of Commons Standing Committee decided to continue hearings on the FDM.

Meanwhile, INTERCEDE thanks all organizations who have sent copies of their letters to Minister Bernard Valcourt of Immigration opposing the FDM admission criteria. A special thanks and "abrazos" to Colectivo Atabal for their letter. Colectivo Atabal is a support group in Mexico City that promotes domestic workers' rights and with whom INTERCEDE met last February.

renewals, student authorizations and fees for processing applications for permanent residence.

But so far, no consideration has been given to lowering these fees in proportion to domestic workers' wages.

About Income Taxes

Q. What documents should I have when filing my income tax return?

It is that time of year: filing your income tax return! Make sure you have: T4 slips from all your employers in 1991; receipts of money orders, remittances, bank drafts etc. that you sent to your dependents who are not in Canada; receipts for school or upgrading course payments; receipts for dental and other medical services.

Q. I corrected misrepresentation of my marital status with Immigration six months after I arrived in Canada. Can I now declare and claim dependent children when I file my tax return and not be questioned by Revenue Canada?

Send a letter with your tax return explaining your circumstances and attaching copy of your letter to Immigration correcting your misrepresentation.

Q. My employer issued me a T4 that showed no income tax deductions were made on my salary. I have been working more than 44 hour weeks for a net pay of \$600 a month. What should I do?

Clarify this with your employer and ask that your T4 be corrected to show the amount of your gross earnings. If you have been receiving \$600 a month, it is clear this is your net pay and not your gross earnings and therefore, tax deductions have been made by the employer.

If your employer refuses to correct your T4 slip, you should still file your income tax return and show what you calculate as income tax deductions made from your salary; accompany your return with a letter of explanation.

Or, before sending your income tax return, you can go to a Revenue Canada district office and file a complaint about not receiving a correct T4 so that Revenue Canada can contact your employer for a corrected T4.

Q. I worked February to December 1991 with an employer who now refuses to give me a T4 slip and who informs me that I was not declared as their employee because I was receiving \$700 in cash each month.

Go ahead and file an income tax return and attach proof of your employment such as copy of contract with this employer, copy of your employment authorization showing the employer's name; and as well, attach proof that you were receiving \$700 a month net pay and that you were working as a live-in domestic worker.
