# FOREIGN DOMESTIC WORKERS WRITE TO MINISTER MARCHIE PLEASE STOP CONTINUING DISCRIMINATION AGAINST US!

Sergio Marchi, Minister of Citizenship and Immigration, received more than 30 handwritten letters from INTERCEDE members describing some of the impact of the Live-in Caregiver Program (LCP) on their lives and asking him to end discrimination against them.

Minister Marchi received the letters during a meeting held with the National Action Committee on the Status of Women (NAC) including its president, Sunera Thobani, and members of its executive, Flora Fernandez and Fely Villasin, coordinator of INTERCEDE and one of NAC's vice-presidents.

Among the issues taken up at the meeting apart from the LCP were the immigration policy review process and the plight of women seeking refuge from gender-based persecution and domestic violence in particular.

In a letter handed to Minister Marchi, Villasin highlighted immigration rules and practices that should be changed or eliminated to end discrimination suffered by foreign caregivers and domestic workers, including:

"1. the entry criteria of the LCP that excludes women who don't have an equivalent of a Canadian secondary education (Grade 12) and that requires them to have a six-month full-time training or one-year experience related to the work they are accepting, as well as proficiency in English or French; Continued Page 2

# VANCOUVER'S CDWCR PLEASED OVER RECOMMENDED IMPROVEMENTS TO ESA

The Vancouver Committee for Domestic Workers and Caregivers Rights, an affiliate organization of INTERCEDE, was pleased to learn recently that recommendations made to the British Columbia Employment Standards Act (ESA) may soon give domestic workers minimum wage and hours of work protection.

Up to now, domestic workers in British Columbia are excluded from the provisions of the ESA regarding minimum wage and hours of work. CDWCR has asked the B.C. Ministry of Labour to act quickly on these improvements.

Other recommended changes would give the Labour ministry the authority to approve living accommodations and rent charged. CDWCR hopes this would ensure that rooms rented to live-in workers would be standardized and be more acceptable.

CDWCR members expressed concern however over the absence of concrete recommendations for Continued Page 2

- the requirement that they live-in their employer's household as a condition of maintaining their temporary status;
- 3. the requirement that restricts them to a single employer specified in their work permit;
- 4. the requirement that if they fail to complete 24 months or two full years, without interruption, of live-in caregiving work within three years from their entry into the program they would forfeit the right to become permanent residents;
- 5. the dependence of a foreign domestic worker's application for permanent residence on her spouse and dependents' eligibility to immigrate to Canada, even after she has completed the requirements for permanent residence under the LCP."

Workers cited problems with the temporary work permit system in the LCP such as the "continuous fear of being sent back", of being deported or being rejected for landed status; of being "forced to work with abusive employers"; of temporary status being used as a "tool" by employers to exploit and take advantage of them; and of

enforcement of the Act or for monitoring of employers. They said that even if domestic workers are legally protected, without strong enforcement provisions, this protection would be meaningless. They will continue to press the B.C. government on stronger enforcement provision and monitoring measures.

A key recommendation made by CDWCR meant to resolve this gap was the creation and mandating of a Central Registry where employers would have been obliged to report the names of domestic workers hired. But the official recommendations made by the Labour ministry do not include the establishment of such a registry.

CDWCR spokesperson, Julie Diesta, said they will press the government for action on its recommendation to create a Central Registry.

"being discriminated from other foreign workers who are admitted as landed immigrants.

They complained about the live-in requirement as a condition of their continued status, of not having "a quiet moment after a long day's work because the kids could go in and out of my unlocked room"; "not having a peaceful sleep for fear of being sexually assaulted by a male employer"; "working long hours and being on call 24 hours of the day"; having "no privacy and being overworked"; and being assigned sub-standard rooms.

The workers asked for a "generic" work permit, one that did not tie them to a specific employer, because "it costs \$100 every time we change employment" even if the employment was terminated by the employer; it is "scary to change employment as this could affect" their landed status application; it limits their freedom to choose the employer they want to work with; and "it may not totally eliminate the abuses but certainly will help lessen them" if a domestic worker is able to change employer more freely.

In her letter Villasin said: "We are requesting you to listen to our appeal and make the necessary changes so that a system of indenture labour that is maintained by the LCP is eliminated and that foreign domestic workers will be treated as equals under immigration policy."

Minister Marchi promised to look into the matters raised by domestic and caregiver workers. Meanwhile, NAC will continue to follow up with the Minister the issues raised above.

surpassed the 19-year-limit because of the long Immigration processing and delay.

Meanwhile, anyone of you or your friends who are experiencing problems with delays of more than two years in getting approved for landed status, do call INTERCEDE's office for assistance.

#### News from Coordinator Fely Villasin:

Ihave just attended a three-day forum on "people's alternatives to economic integration" in the "land of Zapata", Oaxtepec, Mexico where grassroots women's organizations and other social movements and networks sent representatives from Central and South America, the U.S. and Canada.

Conference participants shared experiences on the impact, specially on women, of NAFTA and global restructuring that is integrating the economies of these regions.

Like in Canada, the global restructuring is being implemented on the backs of women who are being pushed into lower paying, more insecure, more informal economy and being pushed back to the homes to do unpaid domestic and caregiving work.

Alternative organizing methods highlighted the conference, popular and grassroots organizations are creating ways of countering the assault on the poorest and most vulnerable sectors of society.

On my fourth day, I resumed contacts with Colectibo Ataval whose leaders I met two years ago and who claimed they were inspired by the work of INTERCEDE and have now expanded their work and outreach to Mexico City's domestic workers.

They are hosting the third international conference of domestic workers in Mexico City in March 1995. So, save your money if you want to go with INTERCEDE to attend this Latin American/Caribbean conference for the first time!
