MEETING WITH CITIZENSHIP & IMMIGRATION CANADA

On March 26th INTERCEDE hosted a group meeting with Antoinette De Kir, Programs Specialist for Social Policy and Programs Division of Citizenship and Immigration Canada (CIC), Robert Fisher from the Foreign Worker Recruitment Ontario Region of Human Resources Development Canada (HRDC), Elizabeth Salvilla, President of the INTERCEDE Board of Directors, Karen Dick from the Workers Information Centre, and Professor Sedef Arat-Koc of Trent University and the author of *Caregivers Break the Silence*.

INTERCEDE counsellors, Coco Diaz and Salma Saadi joined the discussion on the Live-in Caregiver Program's (LCP) impact on workers and our recommendations for change.

We said that the LCP forces caregivers to tolerate abusive work conditions because they are too scared to leave their employer or advocate for their rights because of their temporary work status. We also talked about mistreatment by employment agencies, the difficulty of completing the 24-month live-in requirement in three years, the lengthy processing time by HRDC and CIC, the role of employment contracts, labour abuses, and the need for HRDC, CIC and the Ministry of Labour to work together.

When INTERCEDE was asked what could make the program better for caregivers, we said that caregivers must be granted landed status instead of temporary work permits and the live-in requirement should be optional. We also suggested that there only be one generic work permit, so that caregivers would not have to apply for a new permit with each new employer.

CIC plans to hold roundtable discussions in Ottawa to further assess the Live-in Caregiver Program. INTERCEDE will participate in those meetings. In the meantime, INTERCEDE and our partner advocates will submit a letter to CIC to reinforce our ideas and recommendations.


NEW LOCATION FOR SUNDAY INTERCEDE MAY 2, 2004, MONTHLY MEETING

CARIBBEAN CONNECTION

On Saturday March 13th, the Caribbean Connection: IN-TERCEDE Black Support Group welcomed guest speaker Camille deHaney to facilitate a discussion of coping with stress. Camille is a Child and Youth Worker from the Epilepsy Association of Toronto and has been working in the social work field for the last ten years. She has extensive experience leading workshops on coping with stress and finding the power within oneself.

Camille asked members of the Caribbean Connection to discuss the types of stresses they encounter in their lives. Women said the majority of stress comes from dealing with immigration and labour-related problems that are connected to lack of money and being separated from their tamilies.

Camille validated the extensive systemic barriers faced by the women in the group and encouraged them to visualize a plan for a better future and find solace in "a spiritual anchor" of their choice.

The women were guided on how to find the power and beauty within, and stay focused and determined that the future will hold good things. The women had a very positive response to Camille's presentation and many acknowledged that they felt stronger and more positive after meeting as a group.

- Q: I have applied for Permanent Residence and an open work permit. Do I have to apply for an extension of work permit too?
- A: You must always have a valid work permit, even while your application for Permanent Residence and open work permit are being processed. If you do not renew your work permit before it expires, you will be out of status. However, you have 90 days upon expiry of your work permit to apply for restoration of status. The application for restoration of status costs \$200.00, and the application to renew your work permit costs an additional \$150.00.

If 90 days has lapsed and you do not apply for restoration of status, Immigration will send you a letter advising you to leave Canada because you are without valid status.

- Q: What documents do I need from my employer if I am terminated?
- A: Be sure to ask for your Record of Employment (ROE), and if possible your income tax record or T4. If were fired during the middle of the year, your employer may issue your T4 in February or March of the following year. This will still give you enough time to file your income tax return.

Aside from your ROE, ask your employer for a letter stating the date you started working with a valid work permit and the date your employment was terminated. You can use this letter as proof of employment when you file for Permanent Residence. For more information call INTERCEDE and talk to any of the counselors.

- Q: My previous employer terminated me in October 2003. I requested my T4 but until now she has not returned my calls. I tried to talk to her in person, but I was told she was out of town. I know that I received a net income of \$860.00 monthly but unfortunately, I did not receive any pay stubs. I want to file my income tax return because I know Immigration will ask me to submit a Notice of Assessment when I apply for Permanent Residence. What should I do?
- A: Come to INTERCEDE's Tax Clinic on April 4th at Cecil Community Centre. Bring your Notice of Assessment and any other documents you have. There will be Filipino Canadian accountants who will compute income tax returns for all INTERCEDE members free of charge. Everyone is welcome.

Please note that all workers have a right to ask for a statement of earnings (i.e. pay slip or pay stub) whenever you receive your pay. It should state all the deductions from your salary.

- Q: Do I have to meet the income requirement when I sponsor my husband?
- A: No, since he is your family member, Immigration will not ask you to meet the income requirement but you must provide a letter from your employer confirming that you are employed full-time. If you plan to sponsor

your parents and/or brothers and sisters (who are underage), you will be required to meet the income requirement also known as low-income cut-off. 00000000000
