# KIM CAMPBELL SHIFTS IMMIGRATION TO MINISTRY OF PUBLIC SECURITY

Domestic workers and caregivers in the Live-In Caregiver Program (LCP) will now fall under a ministry in charge of criminal matters!

INTERCEDE members expressed disgust and dismay at this move by Canada's first woman Prime Minister, Kim Campbell, who has shifted most of immigration responsibilities to the Ministry of Public Security.

As a result of her decision to reorganize the federal government, the Canada Employment and Immigration ministry no longer exists. The Ministry of Public Security will take over policy, selection and enforcement related to immigration.

It was chilling news for women in the LCP who, because of the insecurity of their status during their first three to five years in Canada, always live in fear or dread of immigration authorities.

"It's like we are under suspicion of doing something wrong...but we just came to earn a living. Isn't that why we got admitted, because they need us to do live-in work?" one woman asked.

"It makes us feel more insecure!" - was an ironic comment from another.

# What's in a name? Plenty!

The Minister of Public Security, Doug Lewis, is responsible for the RCMP, criminal investigations, prisons and parole - mainly law enforcement and crime prevention.

Putting immigration policy in his hands "is an antiimmigrant move" according to the Canadian Council for Refugees, an organization of 130 groups, because it gives the message that immigrants or refugees are threats to public security.

# NDP WILL NOT END OHIP FOR LCP WORKERS, REFUGEES

Shock waves in the immigrant and refugee communities followed the announcement by the Ontario Minister of Health, Ruth Grier, that temporary residents of the province could lose universal health coverage!

But in a meeting of Premier Bob Rae's cabinet to discuss the plan, it was decided that there would be no loss of OHIP coverage for refugees and temporary workers, including domestic and caregiver workers under the Live-in Caregiver Program (LCP).

In a telephone call to INTERCEDE, Marie Lorenzo, Policy Assistant to Minister Grier, assured that OHIP will continue covering "foreign workers", convention refugees and refugee claimants but that meanwhile, negotiations will be pursued with the Federal Government to take up health coverage for claimants.

"It would have been inexcusable for the NDP government to penalize the most vulnerable residents and workers in the province in order to reduce the health care budget!" said INTERCEDE president, Joan Grant-Cummings. Cummings is the executive director of Women's Health in Women's Hands, a community-based health organization that will be hit by the province's social contract provisions.

Premier Bob Rae's cabinet was considering a "tough" plan to require about 167,000 residents who are on temporary immigration status to pay for medical care.

Members and clients of INTERCEDE, their relatives and friends kept the phones busy at INTERCEDE's office inquiring about the news of Grier's announcement, expressing their disbelief and concern.

In a letter to Minister Grier, INTERCEDE had objected to eliminating OHIP coverage for 43,800 temporary workers, 93,000 refugees, 20,000 foreign students and 9,800 Minister's Permit holders residing in the province.

"Prime Minister Kim Campbell thinks immigrants are in the same league as convicted criminals and potential troublemakers from whom the nation needs protection", the Toronto Star wrote in its editorial.

The Liberal Party's Immigration critic, Warren Allmand, "condemned" Campbell's decision that, he said, was made with no consultation nor proper planning, and that will "not result in greater efficiency nor saving".

### Negative images

Millions of migrants roam the world in search of a better life; domestic workers, like most immigrants in Canada, left their country because of economic and social devastation caused by unequal economic relations among countries. Refugees flee for their lives from wars and political turmoil that directly result from these economic and social imbalances.

However, there are many incorrect and racist images of immigrants and refugees. They are made scape-goats during hard economic times, when myths abound like "immigrants take away jobs" from "Canadians", where "immigrants" are usually pictured as people of colour, and "Canadians" as whites.

Making immigration the responsibility of the Ministry of Public Security aggravates false images of immigrants and refugees as terrorists, criminals and cheaters of the system.

No matter what the justification, by transferring immigration to Public Security, the message that Kim Campbell sends to Canadians is a negative image of immigrants, refugees, and women working under the Live-in Caregiver Program.

"Eliminating OHIP will further aggravate the difficult conditions of life and work that foreign women are experiencing as live-in domestics and caregivers under the LCP," the letter said.

LCP is the Live-in Caregiver Program devised by the federal immigration ministry to meet the high demand in Canada for foreign women who will provide a combination of live-in housework and caregiving services.

More than 61 per cent of LCP applicants wind up in Ontario every year. The program allows these women to apply for permanent residence within Canada after they have completed 24 months of working as live-in nannies and caregivers.

But it has usually taken them an average of five years from their arrival before they become permanent residents. Because the LCP keeps domestic and caregiver workers on temporary status for that long, "eliminating access to universal health care services would penalize them through no fault of their own," the letter added.

Based on the number of LCP workers entering Canada yearly since 1989, INTERCEDE's rough estimate is that up to 18,300 domestic and caregiver workers may currently be temporary residents of Ontario. "These are the women who will have no medical coverage under OHIP if your Ministry's proposal is passed," the letter said.

Asking the Minister's assurance that OHIP coverage will continue for temporary workers in the LCP,

INTERCEDE rejected any justification for a "change in health policy that would penalize the most powerless people living in Ontario."

For now, LCP workers in Ontario can breathe a sigh of relief because they will continue to have access to health care services.

# NEW REGULATIONS WILL KEEP OUT ACCUSED

Loida (not her real name) was accused by her employer of stealing an old TV set. She still has to go to court to prove that the TV was a "gift" given her when her employers bought a new one.

Why did her employers do this? Because Loida could no longer tolerate working up to 15 hours a day and she decided to leave.

But even if Loida is innocent, immigration regulations being proposed to take effect this summer would not admit her for landed status.

In response to these proposed regulations, the National Association of Women and the Law (NAWL), National Organization of Immigrant and Visible Minority Women of Canada (NOIVIMC) and INTERCEDE jointly made a submission to Immigration.

In their submission, they noted that Canada's Immigration Act and the new regulations continue the bias against women who universally have less access to training, education, and health services.

For example the greater emphasis on language and education qualifications will "disadvantage female immigrants disproportionately."

In addition, how educational accreditation will be done is unclear. How ability to speak, write and read French or English will be assessed is also unclear and may give too much discretionary power to an immigration officer.

The submission "strongly objected to the regulations which would exclude people who are facing criminal charge" from being processed for landing.

It said: "In our experience, domestic workers are particularly vulnerable to false accusations from disgruntled employers where the domestic workers have sought to enforce their rights under employment standards legislations."

The regulations will discourage domestic workers from insisting on their lawful rights. But worse, they will give unscrupulous employers another weapon with which to threaten and exploit domestic workers.
