SERVICE UNIT OPENS!

Sunday, May 6, is the BIG DAY. All our members and friends are invited to an OPEN HOUSE to mark the official opening of the INTERCEDE SERVICE UNIT. We celebrate the only community-based service in Canada dedicated exclusively to the needs of foreign domestic workers.

The SERVICE UNIT will operate on a full-time basis and offer in-depth counselling to domestics applying for landing. It will also handle employer-related problems and human rights issues. Information and referral will also be available on social service, health and emergency matters.

INTERCEDE lobbied long and hard to make the SERVICE UNIT a reality, and it is an important victory for the rights of domestics in this country.

The SERVICE UNIT is <u>funded for one year</u> by Immigration Minister John Roberts, through a special grant from the Immigrant Settlement and Adaptation Program (ISAP).

Two full-time counsellors, COLUMBIA TARAPE, from the Philippines, and DESIREE HIPPLEWITH, from Guyana, have been hired by the Steering Committee. Since coming on staff in March, they have been undergoing an intensive training program. Already, Coco and Desiree have counselled over 100 domestic workers.

INTERCEDE Co-ordinator JUDITH RAMIREZ is supervising the daily operation of the SER-VICE UNIT. She brings to it many years of experience developing grass-roots services by and for immigrant women.

APPEALING REJECTIONS

If you have been refused landing in Canada, don't take "no" for an answer! You may have grounds for appealing the decision.

The SERVICE UNIT is working with local immigration offices to have <u>rejections reviewed</u>. We also take cases directly to Immigration Minister John Roberts in Ottawa. The minister has recently appointed a <u>special assistant</u> to review cases.

So, if you have been turned down, don't get discouraged! Call the SERVICE UNIT at (416) 929-3240 and we will look into your case without delay.

All INTERCEDE services are free of charge.

MELROSE MORGAN WINS APPEAL

Mrs. Melrose Morgan is a domestic worker from Jamaica, mother of four, and has been in Canada since 1979. She was turned down for landing in April 1983.

Two reviews of her case, the first by the local immigration office and the second by Ontario Region, both upheld the original decision to refuse landing.

On March 30, 1984, she contacted the SERVICE UNIT and we took her case directly to Ottawa. Immigration Minister John Roberts has granted her a six-month extension, and she is now completing her upgrading and looking forward to another assessment under the program. Congratulations, Mrs. Morgan!

KNOW YOUR RIGHTS

On March 1, 1984, the Ontario minimum wage for domestic workers went up to \$3.35 per hour. The new rate for foreign domestics on work permits is:

\$ 792.50 Gross Pay (per month)

From that amount, your employer can deduct:

\$ 234.00 Room & Board

Plus, the employer must deduct:

\$ 70.15 Income Tax

11.27 Canada Pension

18.23 Unemployment Insurance

That leaves you with: \$ 458.85 Net Pay

SUPPORT FOR PROVINCIAL BRIEF

Last November, INTERCEDE met with Ontario Labour Minister Russell Ramsay. We presented him a brief calling for immediate changes in provinvial labour laws to take domestic workers out of the dark ages.

Chief among our recommendations is <u>bringing</u> domestics up to the standard minimum wage. At present we lag a full 50¢ behind other workers. In our brief we said:

In regulating a below-the-standard minimum wage for domestic work, the Government of Ontario both reflected and reinforced the traditional prejudice against work in the home.

The other key issue is including domestic work under the hours of work and overtime provisions of the Employment Standards Act. Did you know that in Ontario it is legally possible for a domestic to work or be on call to her employer for up to 120 hours per week. That brings her real hourly wage down to \$1.00 and change. In our brief we said to the minister:

INTERCEDE wishes to underscore the fact that domestic workers...are still among the most exploited and under-protected workers in the province of Ontario.

Mr. Ramsay assured us that he would be studying our recommendations carefully, but so far, six months later, we have had no response from the minister.

The only recent change is that, as of March 1, 1984, domestics are entitled to an additional 12 hours off per week. But these do not have to be consecutive to the first 36!

INTERCEDE has launched a province-wide drive to pressure the Ontario Government to act without further delay.

Letters of support for our recommendations have been sent to Russell Ramsay from the Social Action Committee of the YWCA, Metro Labour Council, the United Church of Canada, and prominent individuals such as Toronto lawyer Mary Eberts.

WHAT OUR SUPPORTES ARE SAYING:

"Domestic workers have historically been among the most exploited in Canada. Although recent administrative and legislative amendments have improved matters, more needs to be done to bring the working conditions of domestic workers in line with those of other workers in Ontario.

- "I try to raise my children to have respect for domestic work, for people who work for them, and for one another. I do not think that it is possible to raise children who have a real appreciation of human dignity if those children are raised in a home where exploitation of another human being is practiced on a regular basis. People who see the undervaluing of their nannies, and others who may give services in the home to their families, will not themselves be able to grow into respecting and respected human beings.
- "...The longer this government tries to get child care "on the cheap" or countenances the efforts of private individuals who try to get child care "on the cheap", the more this government is short changing out future."

DESIREE'S CROSS-COUNTRY DIGEST

In the past year, INTERCEDE Co-ordinator JUDITH RAMIREZ has been travelling across Canada reaching out to domestics and hearing their cry:

- * in March, she was in London, Ontario, where she appeared on two CBC television programs and met with local groups. Women Immigrants of London and Cross Cultural Learner Centre are both concerned about the rights of domestics in the London area, and are now offering assistance with the SERVICE UNIT as back-up
- * last November, Judith gave the keynote address at a seminar on domestic workers' rights in Winnipeg, Manitoba. The event was sponsored by the Philippine Homemakers Association, the Immigrant Women's Association of Manitoba, and the Congress of Black Women. The seminar was widely covered by the media, with articles in the Winnipeg Free Press, the Winnipeg Sun, and the Toronto Star.
- * last September, Judith was in Halifax, Nova Scotia, for the "First Provincial Immigrant Women's Conference". She gave a keynote address on lobbying for legislative change. The event was sponsored by the Metropolitan Immigrant Settlement Association and attended by representatives from 18 local groups.
