GREGORY SORBARA MEETS WITH INTERCEDE

On May 16, 1988, Minister of Labour, Gregory Sorbara met with an INTER-CEDE delegation to discuss the need for equitable overtime compensation for domestic workers.

The brief objective of the hour-long meeting was to appeal to Mr. Sorbara to amend the overtime regulations introduced last October. "They look good on paper", said Judith Ramirez INTERCEDE Co-ordinator, "but they make little difference in the lives of most live-in domestics."

Melita Carbungco, a plaintiff in the overtime Charter challenge launched last Spring, told the Minister she was taking a stand to help all the foreign domestic's who cannot complain for fear of losing their jobs. "I know", she said, "because it happened to me."

Mary Jo Delorme, the first foreign domestic to file a claim for overtime pay, told the Minister how she had worked long hours caring for an infant child. Mr. Sorbara responded that he knew what it was like from raising six children and taking turns with his wife getting up in the middle of the night. "It's not the same", said Ms. Delorme, "the baby I looked after was not my own... [and] the law made it easy for my employers to exploit me."

The Ontario Federation of Labour's Sean O'Flynn noted that "it is no accident ninety eight per cent of domestic workers are women and the majority are immigrants." He deplored the fact that it is illegal for domestics to unionize and called on the Minister to "grant INTERCEDE's request for immediate changes in

the law."

Helena Orton, Litigation Director for the Women's Legal Education and Action Fund (LEAF) told Mr. Sorbara that there is a strong legal case against the current overtime regulations under the Charter of Rights and Freedoms because "they create more hoops for domestic workers to jump through to get overtime pay" and this constitutes unequal treatment under the law.

While conceding that the Charter challenge may require government to "change direction", the Minister insisted that there would be "no substantive change in the legislation in the forseeable future."

Due to the Minister's refusal to negotiate with INTERCEDE, new affidavits have been filed with the Supreme Court of Ontario charging the government with perpetuating the long legacy of exploitation against domestic workers.

OFL JOINS CHARTER CHALLENGE

The Ontario Federation of Labour has formally joined INTERCEDE in the court battle to win overtime pay for Ontario's 65,000 domestic workers.

In an affidavit filed immediately after our recent meeting with the Minister of Labour, Sean O'Flynn condemns the current overtime regulations saying "they contain many retrograde features."

The regulations came into effect last October and permit employers to give live-in domestics time off in lieu of overtime pay with the worker's "consent." The OFL refers to the domestics ability to give her consent as cont'd pg. 3

KNOW YOUR RIGHTS

If you are a domestic worker in Ontario, you are entitled to compensation for any hours worked after 44 hours per week.

Overtime pay is calculated at time and a half your regular rate of pay. For example, \$4.55/hr. + \$2.28 = \$6.83/hr. Here are some things to remember about overtime pay:

- you must keep records of your hours worked in the event of a dispute with your employers.
- your employer can offer you time off (lieu time) instead of overtime wages. You have to give your consent to receive time in lieu of money. If you don't want time tell your employer no.
- you have up to 2 years to make a claim for overtime wages owing to you.
- if your present employer fails to pay you properly you can still make a claim after you leave.

If you are having problems with wages or long hours, call us or the Ministry of Labour for assistance.

'illusory' given her lack of bargaining power with the employer. It
strongly supports INTERCEDE's demand
that lieu time be dropped and domestics be granted time and a half after forty four hours a week with no
strings attached.

The court case against the Ontario Government was launched by INTERCEDE and LEAF last Spring with the support of organizations such as the YWCA, the Congress of Black Women of Canada, the Ontario Advisory Council on Women's Issues, the National Organization of Immigrant & Visible Minority Women, and the National Action Committee on the Status of Women (NAC).

DID YOU KNOW?

- * the average annual income of employers who recruit foreign domestic's through a Canada Employment Centre is \$77,499 (gross);
- * the annual income of most live-in domestic's is \$10,410 (gross), with \$2,964 deducted by the employer for room and board;
- * the net income of live-in domestic's after all deductions is less that \$6,000 a year;
- * the Ontario Task Force on Hours of Work and Overtime recently recommended that live-in domestic's work a maximum of fifty hours a week, or six hours of overtime weekly
- * six hours of overtime would cost the employer \$40.98 a week or roughly one hour's work!
- * INTERCEDE and community supporters have been lobbying the provincial government to grant overtime pay to domestic workers for nearly a decade

NDP TAKES SORBARA TO TASK

Immediately following his meeting with INTERCEDE on May 16, Labour Minister Gregory Sorbara faced tough questions in the Legislature about domestic workers' rights.

The New Democratic Party's labour critic Bob Mackenzie, took Sorbara to task for refusing to negotiate changes in labour regulations which would avoid a battle in the courts.

In response, Mr. Sorbara said that in his discussion with INTERCEDE he learned that the overtime provision "was certainly not being taken advantage of in the appropriate way by the workforce".

Mr. Mackenzie shot back: "I will try very carefully to tell the Minister so he understands. With no right to organize into a union, no maximum hours and no way to enforce the hours of work or payment of overtime, these immigrant workers have now been forced to go to court under the Charter of Rights. Is this the way the Liberal government looks after immigrant and ethnic minorities; passing legislation that allows continued exploitation, even when warned of it, and then arrogantly telling the delegation this morning, as he did, that he is not prepared to sit down with INTERCEDE to negotiate changes in the regulations that might give them the protection?"

Mr. Sorbara replied; "I resent the tone of voice from my friend...and the suggestion that I was not willing to listen to INTERCEDE's point of view..."

The NDP has often raised its voice at Queen's Park to protest the discriminatory treatment of domestic workers under the province's labour laws.
