IAN SCOTT BACKS CHANGES IN LABOUR LAWS!

On November 13, 1985, an INTERCEDE delegation met with Ontario's Attorney General Ian Scott, Minister Responsible for Women's Issues.

Led by INTERCEDE Co-ordinator Judith Ramirez, the delegation also included Ellen Campbell, Executive Director of the Toronto YWCA; Maria Wallis, of the National Action Committee on the Status of Women; Ceta Ramkhalawansingh and Bridget Vianna, of the Ontario Advisory Council on Women's Issues.

The hour-long discussion focused on our current efforts to win changes in the Employment Standards Act and the Labour Relations Act to protect domestics from exploitation. Ian Scott was clearly familiar with the key issues, and he commended INTER-CEDE on our "research and hard-nosed positions".

One of the points raised by the Minister was the danger of adversely affecting demand for live-in domestic work is wages rise "beyond what the market can bear". We replied that demand has actually risen since the Immigration Commission has been requiring a pay rate of 25% above the Ontario minimum wage for foreign domestics. When the policy was first introduced in 1981, there were roughly 11,000 foreign live-in domestics in Canada, but by 1984 the number had risen to over 15,700 - an increase of 43%! An estimated two-thirds of these domestics live and work in Ontario.

Mr. Scott also raised the issue of recordkeeping. In calling for a limit on the hours of work of live-in domestics, INTERCEDE has been stressing the need to require employers to keep records. Some employers are opposed to this, presumably because it involves government bureaucracy "invading" their homes. The Minister suggested that domestic workers keep the records and that employers' sign them. We replied that our main concern is insuring that there be <u>some</u> mechanism for employer accountability. If there isn't, then any limit set on the hours of work will not be taken seriously.

At the close of the meeting Mr. Scott assured INTERCEDE of his personal support, and he indicated that he would communicate our concerns to <u>Min</u>ister of Labour William Wrye.

BOB RAE PLEDGES NDP SUPPORT

The week before our meeting with Ian Scott, INTERCEDE met with Ontario NDP Leader Bob Rae. Also present were Bob MacKenzie, NDP Labour Critic, and Evelyn Gigantes, NDP Women's Issues Critic.

Judith Ramirez and Cathy Gilbert represented INTERCEDE at the meeting, and they were joined by <u>Shirin Perston</u>, of the YWCA's Social Action Committee.

Our delegation emphasized the fact that live-in domestics are denied the minimum wage, to which they are legally entitled, because there is no control of the hours of work. "It's a case of giving them the money with one hand and taking it away with the other" said Judith Ramirez.

Mr. Rae asked INTERCEDE to provide him with recent case histories of abuses by employers. He said that the information would strengthen the NDP's efforts to pressure the Liberal Government to take immediate action. We agreed to provide the documentation,

and have since drawn nine cases from our current files for Mr. Rae (see page 3).

At the close of the meeting <u>Bob Rae</u> assured INTERCEDE of his personal commitment to domestic workers' rights and said he and his party would work closely with us to achieve legislative reform.

KNOW YOUR RIGHTS

If you are a live-in domestic worker you are entitled to one free period of 36 consecutive hours and another free period of 12 consecutive hours per week. The two periods can be combined so you get one free period of 48 consecutive hours, if your employer agrees to it.

No deduction from your wages can be made for your weekly time off work. It is time off with pay.

Your employer can ask you to work during your two free periods, but only with your consent. You have a right to say NO!

If you do agree to work during a free period, you are entitled to <u>compensating</u> <u>time off</u> at the rate of 1½ hours off for every 1 hour worked. You have up to four weeks to add this extra time to one of your free periods.

If you do not get the extra time off, you are entitled to <u>overtime pay</u> (\$6.00 per hour) for each hour worked. This money is owed to you <u>in addition</u> to your regular weekly or monthly wages.

Keep your own records so you will know what time or money your employer owes you!

" We were shocked when we realized that live-in domestic workers have so little protection under Ontario labour law. Although these workers perform a valuable service - what could be more valuable than caring for children? - there is no provision in the law to ensure that they are receiving overtime pay. They are paid for 44 hours a week, but can be required to work up to 120 hours a week, which means that they can end up working at approximately one third of the minimum wage. These women are particularly vulnerable to exploitation and we would certainly like to see them given the same protection under Ontario law as other workers.

The Liberal government has thus far demonstrated an awarness and concern about women's issues and we hope that you continue to show this by proposing legislation to protect domestic workers."
