# MAYOR EGGLETON BACKS CHANGES IN LABOUR LAW

On October 9, 1984, INTERCEDE appeared before the Mayor's Committee on Community and Race Relations to seek support for changes in Ontario's labour laws. The Committee had been studying our brief "Upgrading the Status of Domestic Workers in Ontario" for several months.

At a previous meeting on September 11, 1984, the Mayor's Committee had failed to reach a decision due to objections from one of its members who held that the "abuse of domestic workers is a thing of the past". At that meeting, Desiree Hipplewith, a former domestic from Guyana, had been questioned in a hostile way, ostensibly because "she is putting herself forward as a victim of abuse".

In a letter to Mayor Art Eggleton INTERCEDE objected to the disrespectful treatment of our delegation. We asked for, and received, assurances that the Mayor, himself, would be presiding over the next meeting.

Our October 9 delegation was led by INTERCE-DE Co-ordinator Judith Ramirez, and two domestic workers on temporary work permits, Elvira Boncato (Philippines) and Patricia Mapp-Ottley (West Indies). Also included in our delegation were: Carmencita Hernandez, of Kababayan Community Centre; Akua Benjamin, of the Congress of Black Women and the Ontario Coalition of Visible Minority Women; and Alison Kerr, of the Social Action Committee of the YWCA.

We urged the Mayor's Committee to take a decisive stand on behalf of domestic workers' rights. Akua Benjamin pointed out that the issue "is a fight against racism and sexism", and Alison Kerr stressed that "longstanding abuses must be ended".

Members of the audience were also moved to speak out: former Ontario Human Rights Commissioner Bromley Armstrong appealed to the Mayor to support all the INTERCEDE recommendations "because they (INTERCEDE) are in the trenches and they know what the issues are".

Trevor Hitner, an equal opportunity consultant, underscored the fact that "the principle underlying all the recommendations is that domestic work should be treated just like work in an office or a factory".

After deliberating for one hour, the Mayor's Committee voted overwhelmingly in favor of endorsing all the INTERCEDE recommendations in principle. The motion was put forward by Alok Mukejii and seconded by Anne White.

In bringing the meeting to a close, Mayor Art Eggleton said that he strongly supports the efforts of INTERCEDE for "their pioneering work which many people in the future will appreciate."

INTERCEDE's letter-writing campaign to Ontario Labour Minister Russell Ramsay is still going strong! We are now awaiting the release of the study commissioned by the Minister on the "prevailing wages and working conditions" of domestic workers in Ontario.

#### KNOW YOUR RIGHTS

On October 1, 1984, the Ontario minimum wage for domestic workers rose to \$3.50 per hour. If you are a landed immigrant in Canada, the very least your employer must pay you is:

Monthly	\$662.00	Gross Pay
	238.00	Room & Board
	36.80	Income Tax
	8.92	Canada Pension
	15.23	U.I.

That leaves you with: 363.05 NET PAY

Weekly

154.00 Gross Pay
55.00 Room & Board
8.70 Income Tax
2.08 Canada Pension
3.54 U.I.

That leaves you with: 84.68 NET PAY

If you are an experienced domestic worker you can negotiate a much higher rate of pay with your employer. The above is only the legal minimum. For more information about your rights contact:

# MELROSE MORGAN APPEALS TO NEW MINISTER

Melrose Morgan is a domestic worker from Jamaica who has been in Canada since 1979. She was refused landing in 1983 and ordered to leave Canada by April 9, 1984.

In our May newsletter we reported that Melrose Morgan had come to the INTERCEDE Service Unit in March, 1984, and that a sixmonth extension had been granted by immigration officials. INTERCEDE immediately
appealed her rejection to then Immigration
Minister John Roberts, who said that Mrs.
Morgan would be re-assessed if she successfully completed her upgrading.

In June, 1984, INTERCEDE wrote to the Minister's office to let him know that Mrs. Morgan had finished her Health Care Aid course with flying colours and that she was ready for re-assessment. John Roberts' office took no action and acted as if no commitment had ever been made.

INTERCEDE had appealed to Mr. Roberts on the grounds that Melrose Morgan had not been able to meet the upgrading requirement because her employer would not give her time off work, even though this is required under the Foreign Domestics Program. The same employer later fired Mrs. Morgan when she became ill and had to be hospitalized for a brief period.

As soon as Mrs. Morgan found new and more sympathetic employers, she began to upgrade herself and take other steps to strengthen her application for landing.

Her present employers, Rubin and Judy Osten, are very happy with Mrs. Morgan's job performance and have extended a long-term offer of employment. Her sister is landed in Canada and ready to assist with settlement plans for Mrs. Morgan's two dependent children, ages 12 and 16.

After the federal election, INTERCEDE appealed to the <u>new Minister of Immigration</u>, Flora MacDonald, to intervene on Melrose Morgan's behalf. We have had no word as yet. In the meantime, Mrs. Morgan's work permit expired on September 30, 1984, and further extensions were denied. She is now in Canada illegally, unable to work, and waiting for the new minister's reply.

Melrose Morgan needs your support. She was promised a re-assessment and she deserves another chance to settle permanently in Canada. She kept her side of the bargain by doing well in her upgrading but the Minister failed her by not keeping his side of the bargain.

# BARBARA DONALDSON ACCEPTED FOR LANDING!

Barbara Donaldson is a domestic worker from Jamaica who came to Canada in July, 1980. She was refused landing in September, 1983, and notified to leave the country by August 17, 1984.

Ms. Donaldson contacted CLASP who appealed the decision to the Ontario Regional Office of the Immigration Commission. She also came to the INTERCEDE Service Unit and, as her counsellor, I asked local immigration officials to review her case. In a letter to Mr. Walter Bye, Supervisor of the Foreign Domestics Program at the 130 Bloor Street Canada Immigration Centre, I requested a re-assessment on the grounds that Barbara had made significant progress in the areas where she was previously weak.

On August 11, 1984, Barbara Donaldson was re-assessed by Walter Bye and granted a one-month extension of her work permit, pending the review of her case at the regional office. Mr. Bye agreed with INTERCE-DE that Barbara was now qualified for landing and he urged the regional office to rule in her favour. We are happy to announce that Barbara Donaldson has just been accepted for landing!
