SEXUAL HARASSMENT AND CONSTITUTIONAL RIGHTS

The British Columbia **Human Rights Code** entitles every worker the right to an employment environment that is free of sexual harassment.

In August 1995, Sister Andrea Wallis filed a formal complaint of sexual harassment with the Human Rights Commission of British Columbia against her boss, Mr. Robin Blencoe. Andrea was Mr. Blencoe's assistant. The complaint was accepted to proceed to an investigation.

In January 1998, Mr. Blencoe appealed to the Supreme Court of BC on the basis of the length of time it took for the case to be heard by the BC Human Rights Commission. The Court's decision was that the case should proceed to a hearing as originally intended.

In March 1998, Mr. Blencoe appealed the above decision. On May 11, 1998, the BC Court of Appeal ruled that the Commission and Human Rights Tribunal's thirty-month delay in dealing with this case was unacceptable and infringed on Mr. Blencoe's constitutional rights.

It is believed that the decision of the BC Court of Appeal has national significance, not only for workers fighting against sexual harassment in the workplace, but by anyone who has a case before Human Rights Commissions through Canada.

Sister Wallis took her case to the BC Human Rights Commission to seek justice for the harassment she experienced in her work environment. This should be simple enough but the BC Court of Appeal decision means that Andrea has to appeal to the Supreme Court of Canada to regain a basic right. Andrea deserves the right to have her story told.

Andrea and her family have incurred significant legal costs due to the appeal hearings. She has until August 10, 1998 to raise enough money for more legal costs as she proceeds to the Supreme

Court of Canada to have the abovementioned decision appealed.

SEX AND POLITICS IN LABOUR UNIONS (by Dr. Suzanne Franzway)

"Sexuality is everywhere. It is the most obvious aspect of gender relations, yet the study of sexuality within work organizations is largely neglected. The literature on trade unionism pays little attention to either gender relations or sexuality. The trade union movement has been dominated by men numerically, culturally and hierarchically throughout its history." Dr. Suzanne Franzway from the Centre for Gender Studies, Magill Campus, University of South Australia, will be in Vancouver during the week of July 6-12.

Dr. Franzway is a lecturer in Gender Studies /Sociology and a long-term activist in her own union. She is conducting follow-up research on women officials in the labour movement - "Gender and Power" - and is interested in meeting and speaking to women about sexual politics in union organizations, policies, practices, and how union women officials manage

the rest of their lives, such as home life and private lives.

She would also like to have an opportunity to interview other union activists - staff or elected - on the above issues.



MARIANNE GILBERT SCHOLARSHIP (Summer Institute for Union Women)

The Marianne Gilbert Scholarship, which is awarded each year to a female trade unionist in BC, was established in Marianne's memory as a fitting testimonial to Marianne's joint commitment to the women's movement and the labour movement. It is funded by donations from persons whose lives she touched profoundly.

Marianne was also a devoted mother to three boys, Eliot, Oliver and Lars, and a wife and companion to Cliff Andstein. She was a professional who excelled in her field; she worked as an audiologist for twenty years at the Jericho School for the Deaf. At work she acted as steward for her union, the BCGEU, and as a mentor and dear friend to her co-workers.

To the best of anyone's memory, Marianne was the first woman rank-and-file member to chair a Federation Committee other than the Women's Committee. She chaired the Occupational Health & Safety Committee.

Marianne was also the first chair of the NDP's Standing Committee on Women's Rights. She was instrumental in its formation in 1971, and remained active in the Committee for many years. Her dedication to women's rights issues carried on throughout her life, and at her death, contributions in her memory to the

year 2000. Almost 300 women's groups in 56 countries are already participating in the project and we hope that your group will join them.

In a world where -- no matter where we live -- violence against women is a daily reality and poverty is making women increasingly vulnerable, global action and solidarity-building are important. Women everywhere are struggling for equality, development and peace. The World March of Women is a stimulating global action that will mark the new millennium by demonstrating women's continuing determination to change the world!
