HI!

Most of you have probably read in the newspapers about the court action OSSOMM is taking against the Attorney General of Canada and the Minister of National Defence. In order to clarify what is happening for our members, I will repeat some of what you already know

When OSSOMM began distributing our newsletter, holding general meetings, and conducting the write-in campaign for a dental plan, we were informed by the Base Administration Officer that we were conducting "Political Activity" on the base. Since this was not allowed according to The QR & O 19:44, we could be charged with trespassing under the Defence Establishment Trespass Regulations. QR & O 19:44 states:

"No officer in command of a base or other unit or element shall:

A. allow a political meeting to be held or a political speech to be delivered at his base or other unit or element." It was apparent that the decision to allow OSSOMM to distribute the newsletters door to door, to have meetings, to conduct a write-in campaign, and to circulate a petition concerning a dangerous intersection, would have to come from a higher authority. This is why in October 1984 we wrote a letter to the Minister of Defence, at the time, Mr. Robert Coates. In April 1985, we received a reply from the Minister of National Defence, Mr. Erik Nielsen. In this letter we were told that he could not grant us the authority we requested because we would pose a threat to the political neutrality of the Canadian Armed Forces

OSSOMM believes that family and social issues do not pose a threat to this neutrality. We also believe that QR & O 19:44 was not intended for spouses of military members. If the article can be applied to the spouses, then OSSOMM argues that this is a denial of our rights as guaranteed by the Charter of Rights and Freedoms. We have filed a claim in Court of Queen's Bench in Calgary, asking the courts to determine if this section is a violation of our rights and freedoms.

In our brief to the Commission of Equality Rights, OSSOMM made six recommendations. These recommendations are:

- Define Prohibited Political Activity under Article 19:44 very specifically to be that which threatens the security of Canada. If there are certain activities which could pose a risk then these should be listed. All other lobbying and participation in the democratic process should be allowed.
- We request Special Status. In requesting special status, we point out that we are not military members but we are civilians 2. living on DND property. This action would grant us our rights but still protect the military from outside civilians.
- Establish a civilian office with official capacity to liase between the DND, government representatives, and families and 3. with the power of an Ombudsman. This office could also provide research which is much needed and sadly lacking with regards to the military and their families.
- Drop the term DEPENDANT or DEPENDANT WIFE from regulations, law documents, publications, etc. This wording is symbolic of the archaic attitudes. It is inappropriate, demeaning and discriminatory. We suggest the terms spouses and
- The investigation and implementation of ways to have democratic elections in PMQ's open to all residents regardless of 5. rank or sex. This should include the office of mayor (or chairman or president). It should also include school board members and trustees. These elections should be outside the jurisdiction of the base commander.
- Investigation into the administration of NPF funds. These funds are generated through the messes and the Canex system. 6. Spouses and ordinary military families contribute to these, yet have no say in the spending of the fund. It is run by the base commander and senior officers.

Due to nationwide publicity as a result of our brief (Sept. 20, 1985) and our simultaneous newsconferences in Toronto and Calgary (Sept. 26, 1985) OSSOMM has gained support across the country. We have no indication of how long the court proceedings will take, however OSSOMM intends to continue our efforts.
