Morning Session

Brief History of OSOMM - Lucie Laliberté

OSOMM is now ten years old. We see OSOMM's role as being a watchdog operation. We must define our own reality.

OSOMM Constitution is retroactive to 5 April 1989.

A vote is necessary to adopt the constitution subject to changing the objective. "To provide...

Also eligibility to be changed to include spouses, present, former and surviving.

A motion made by June Haney, seconded by Joan Woodland, that the constitution be adopted with the above changes. The vote was unanimously approved.

Elections

Lucie Laliberté, Gaila Friars and Marnie Draper allowed their names to stand for re-election, for the term of one year. Chantall Fortin, Betty Alce, Catherine Patterson-Kidd are now members of the executive. The motion was made by June Haney and seconded by Joan Woodland. The vote was carried unanimously. New Business

Lucie explained that our Court Challenge grant of \$30,000 has run out. Nelligan Power of Ottawa had originally agreed to take our case knowing that we only had \$30,000. This has now run out and Nelligan Power has submitted an invoice for \$7,400 over and above the original \$30,000. OSOMM voted not to accept Dougall Brown's (of Nelligan Power) opinion on our case not to proceed. All in favour: unanimously approved.

The firm of Weir Foulds in Toronto has agreed to take on the OSOMM pension case and preparation of charitable foundation status documentation pending the approval expected at the June 2 meeting of the management committee. Weir Foulds are asking for a \$1,500 retainer fee for expenses only as they will work *pro bono*. Betty Alce advised that OSOMM does have some money but that it is presently invested until October 94. The Toronto lawyers may be willing to wait for the money until October.

Lucie will act in an advisory capacity only with Weir Foulds. She will not be on contract, as she was with Nelligan Power, for whom she worked in her legal capacity at one third the usual rate on OSOMM's behalf.

Money available under Court Challenges will again become available in October at which time we will reapply for funding. Provided the criteria remains the same, it is likely that we will qualify.

Moved by Mary Ballantyne that Nelligan Power be replaced on our OSOMM pension court case and be replaced by Weir Foulds of Toronto for expenses only, for approximately \$2,000. Seconded by Muriel Skaalen. As soon as Lucie hears from Weir Fould she will advise OSOMM on their results. They will need an advance of approximately \$1,000. A vote was taken to change lawyers and was unanimously approved.

A junior lawyer from Weir Foulds will do the preparatory work on the OSOMM case, but it will eventually be argued in court by a senior partner. If costs are eventually awarded, the lawyers may get their fee.

Other News

In the Task Force on Violence on Women, OSOMM is the only organization mentioned by name.

Discussion

OSOMM's tentative goals are to:

- apply for Secretary of State funding, and explore other potential fund-raising ventures, the goal being to ensure a financial capability to establish and maintain a national office and hire an executive director;
- run a membership drive;
- make sure that our history as a political movement is documented; we could perhaps find students who are prepared to write their thesis on this subject; and
- continue to work together and lobby effectively on the pension issue. The chair of the pension sub-committee may sit on the executive committee.

There being no further business, the meeting was adjourned.

A vote was taken to switch lawyer and unanimously approved.

We understand that the Court Challenges will be up and running this October. We will be applying for discretionary funding. We also hope to apply to the Secretary of State for funding an office with someone to look after it.
