Dear Friend,

We need your help.

In October 1992 at the Ontario Federation of Labour Women's Conference, the Minister of Labour, Bob MacKenzie promised changes to the Employment Standards Act that would improve wages and working conditions for homeworkers. The changes would ensure that homeworkers have the same rights as other workers. The Coalition first introduced a series of proposals to the Government in November 1991!

We have yet to hear formally from the Minister regarding when amendments to the legislation will be brought forward. A year and a half has been far too long to wait.

Homeworkers, as immigrant women, are among the most vulnerable workers in the province. Homeworkers need these legislative changes now.

Please become part of our letter campaign. Write a letter to Bob MacKenzie, Minister of Labour or attach your letterhead to the enclosed sample letter. Send copies to Premier Bob Rae and Marion Boyd, Minister Responsible for Women's Issues. Let them know you support fair wages and working conditions for homeworkers and expect legislative changes to the Employment Standards Act as soon as possible.

It is only with your help that amendments will be made. Your letter will help to ensure that immigrant women in the garment industry are not left off the legislative agenda.

The Coalition has been very active over the past year: launching the Clean Clothes Campaign, organizing a conference on homework, participating in the International Women's Day rally at the Eaton's Centre, and pushing for legislative changes to the Employment Standards Act.
