MAY 1981

NAC Charitable & Educational Trust Meeting, May 1 NAC Executive Meeting, May 2/3

This meeting followed quickly on the heels of the previous one. The main purpose of the meeting was to set priorities for the coming year, not an easy task given the range of issues NAC is involved in and the general complication of a national organization. However, we had a very successful session and priorities were set, taking into consideration Resolutions from the Annual General Meeting, plans set by the previous Executive, ongoing responsibilities and operational necessities. We were helped in these deliberations by a meeting facilitator, Carmen Paquette. Her efforts helped us.

The next step is to cost the implications of the priority setting exercise - always a tough task. This will be done for the next meeting.

In the meantime, I am empowered to ask Cabinet to meet with us to review the main priorities of NAC for 1981/82. NAC wants to see these priorities reflected in the throne speech. After the June meeting the MEMO will lay out how member groups can actively participate in this lobby.

In addition to setting priorities the Committees of NAC met and laid their plans for the year -- can you imagine 12 committees in full flight? -- it was quite a sight and lots of productive action emerged. The Media Policy Committee now has a chairperson - Alicia Lawrence - and a willing working committee in B.C. Housing is headed up by Caroline Ennis; housing is one of those issues on which little has been done and much more needs to be done.

Other regular business was completed and decisions are reported on in this MEMO. The NAC Trust met and a report is also included here.

If you have any comments on priorities or the method of reporting we are using, please drop me a line.

The following motion was passed unanimously:

"MOVED that Jean Wood, representing NAC, will join with other national women's groups such as CCLOW, CRIAW, Ad Hoc Committee, NAWL, to approach the Canadian Advisory Council on the Status of Women, Status of Women Canada, Labour Canada Women's Bureau, Secretary of State Women's Programmes, to discuss how women will be represented to the government in the next ten years. The discussion will include the structures, functions, roles, responsibilities and relationships of government groups and voluntary organizations. The results of these discussions will be made public."



Native Indian Women 3.

The NAC Executive passed the following motion:

"Moved that a campaign be developed immediately to fight the discrimination of Native Women as legislated in the Indian Act."

THE NAC CHARITABLE & EDUCATIONAL TRUST

The First Annual General Meeting of the NAC TRUST was held on May 1, 1981. The financial report showed over \$14,000.00 in the Trust on March 31st, the end of the fiscal year.

While the Trust is a funding mechanism for NAC, its activities are legally required to be of a "Charitable or Educational" nature. It will therefore commission its own briefs and research, make films or audio/visual presentations, or run conferences, etc., in accordance with certain criteria. Donations may be claimed as exemptions under the Income Tax Act. Ways and means are being considered for developing the Trust financially.

Seven proposals for Trust projects were discussed by the five Trustees (appointed by the NAC executive). The decision was taken at the NAC Executive Meeting that proposals to the Trust be presented to and endorsed by the NAC Executive to ensure conformity to NAC's objectives. Proposals in writing by May 18th will be considered in June, and others later on.

Committee Reports

CONSTITUTION COMMITTEE

The NAC Constitution Committee is compiling recent information on federal/ provincial jurisdictions, fiscal policy arrangements and their effects on women. Although the NAC Executive, at its April meeting, decided <u>not</u> to participate in the conference sponsored by the Canadian Advisory Council on the Status of Women, we are continuing our work in the area and want to ensure that as much information as possible is available to our members. The book of discussion papers which was prepared in August for the CACSW is now available from government bookstores or by mail from the Canadian Government Publishing Centre, Supply & Services Canada, Hull, Quebec KIA 0S9, for \$2.95.

We are actively soliciting additional material (if you have any "good stuff", or can recommend some, please let us know), which, if received by June 1, will be mailed to you at the end of the month. Women have not been idle -- there has been lots of work done on these issues. Help us to collect and distribute it, so that we're all armed for the next round of negotiations.

MEMBERSHIP COMMITTEE

In order to simplify and standardize office procedures, our member year will be from January 1 to December 31 each year. Annual membership reminders will be forwarded December 1 each year and a group will be past due on February 28 when a final reminder will be sent notifying those groups that they are not in good standing.

Annual membership fees are not less than \$25 for groups with fewer than 300 members and not less than \$50 for groups of 300 and more. New memberships accepted during the year will be pro-rated at \$2.25 per month, or \$4.50 per month, depending on size.

IMPACT OF TECHNOLOGY COMMITTEE


The Committee has produced a brief on the impact of the micro-electronics revolution. "The Chips are Down" is available for \$1.00 from the NAC Office.

PENSIONS COMMITTEE

The Committee applied to Monique Begin and Maureen O'Neil, Status of Women Canada, to fund a series of regional pension seminars. Objectives stated:

Analysis of 1981 AGM continues. If your delegates have not returned their evaluation form of the 1981 meeting, <u>please</u> send them before June 5 to the NAC Office.

Child Care: NAC sent letters on the 1981 NAC AGM Child Care resolutions to:

- the Prime Minister, asking transfer of 1% of defense budget to child care, income tax deductions allowed equal to real cost of care, federal leadership in developing quality standards, etc.
- the Canadian Labour Congress, and to Canadian Council on Social Development re above, and noting possibilities for cooperative action.

Alicia Lawrence (NAC) and Hazel Wigdor (CCW) are representing NAC Social Services Committee at a Child Care Meeting, May 4, called by the Ontario Coalition, representing fields of early childhood education, unions, parents, women, teachers, nurses, social workers, social planners.

Committee also:

- Preparing brief to Ontario government based on hearings at eight Forums around province on child care
- Planning immediate action on Throne Speech, calling for Ontario government budget to include \$5-day grant per child in non-profit day care, 10,000 new child care spaces, and Task Force to report on real needs in Ontario for 5-year plan.

Other issues on the plan for this year:

- Reproductive Rights (see coverage in this issue) and continued support of CARAL and other organizations working in this field
- Women's Health a sub-committee is operating to review all areas of women's health and to check out the support for a national Women's Health Conference
- Women & Aging, Sexual Abuse of Children --prepare to follow up these issues as reports on them become available

EMPLOYMENT COMMITTEE

Canadian Human Rights Commission: There is growing pressure being put on the CHRC to widen the guidelines for exemptions to equal pay for equal work legislation (Section). There is a consideration to add "labour shortage in a particular job classification" and "a change in technology". The following addition to the Equal Wages Guidelines is being proposed:

"Where an employer is able to demonstrate to the Commission that a better paid group of employees with whom an equal value comparison is being made, is paid at a higher rate of wages than a third group of employees of the same sex as the better paid group, and where the work done by all three groups is found to be of equal value, the following factors are acceptable to the Commission as justifying the higher wages paid to the better paid group: (1) a labour shortage in the particular job classification;

(2) a change in technology where the job value has decreased but where the wages of the employees in the classification have been maintained at levels established prior to the technological change."

Dear Premier X:

As you know, Canada signed the United Nations Convention on the Elimination of All Forms of Discrimination Against Women, last July in Copenhagen, on the occasion of the United Nations Mid-Decade Conference on Women. All the provinces had to agree before the Convention could be signed, and apparently this agreement was given in record time. Signature indicated intention to ratify, but the Convention does not come into force until ratified. A number of countries have already ratified the Convention, and we hope Canada will also, without further delay.

The Convention on the Elimination of All Forms of Discrimination Against Women contains a number of measures that will improve the status of women, and bring us closer to equality. We urge you to act immediately to give your province's approval to Canada's ratification of the Convention.

REPRODUCTIVE FREEDOM

The anti-choice movement is threatening the rights and freedoms of Canadian women from British Columbia to Newfoundland. According to a 1979 Gallup Poll, 84% of Canadian women were pro-choice and only 5% anti-choice. Yet, through a highly organized and well-financed campaign, politicians on the federal, provincial, and municipal levels are gradually limiting what little abortion freedom there is under the Canadian Law.

ITEM: ST. JOHN'S, NEWFOUNDLAND

It is now virtually impossible to obtain an abortion in Newfoundland. A year ago, three doctors were performing terminations. Today, there is only one. Approved applications for terminations have been cut by approximately seventy-five percent, so that at the present, only three to four applications are approved each week. Since the waiting list is six to seven weeks' long and regulations here do not allow abortions after the twelfth week, many women cannot even get a referral in time. MCP (the provincial medicare program) regulations have also been modified to rule out payments to women using clinics on the mainland. Travel costs have never been covered, even for journeys within the province.

ITEM: HALIFAX, NOVA SCOTIA

Halifax and Dartmouth anti-choice Mayors declared Valentine's Day as antichoice day. They both refused to consider pro-choice tag days. More and more women are being forced to rely on the Victoria General Hospital in Halifax for abortion services.

ITEM: TORONTO, ONTARIO

While on one hand, Cardinal Carter has demanded that Toronto priests stop using the public to distribute anti-abortion, anti-choice literature of the pressure group, Campaign Life, he has also stated that he will "constantly strive to seek legislation to eliminate legal abortion via the Criminal Code or any other item."

Karen Hammond (President, Canadian Abortion Rights Action League) states the problem women face eloquently:

Cardinal's disavowal doesn't meet problem

Emmett Cardinal Carter's move to dissociate the Catholic Church from the anti-choice, anti-abortion pressure group Campaign Life (Pro-Lifers Bitter Over Carter on Militant Group — April 30) is laudable but deserves closer scrutiny.

While distancing his Archdiocese from one anti-abortion organization, Cardinal Carter continues to share the objectives of that organization and all other anti-choice groups. He has stated that he will "constantly strive to seek legislation (to eliminate legal abortion) via the Criminal Code or any other avenue."

Canada is a pluralistic society. There are many religions and many views on abortion; it is unacceptable for one religious group to enshrine its dogma in law. Pro-choice individuals and groups do not seek to impose one morality on all Canadians. No matter how their strategies may differ, anti-choice individuals and anti-choice groups such as the Catholic Church are determined to do just that. These so-called "pro-life" groups attempting to eliminate access to safe, legal abortion would ensure the return of unsafe, illegal abortion and unwilling motherhood, along with all the misery and human suffering these entail. Contrary to the message delivered by Cardinal Carter, we are all pro-life and pro-love. A society that allows safe, legal abortion for those who choose it is a humane society demonstrating its concern for the woman, the family and the community as a whole.



Once the child is born, there is no support from this group for quality child care, safe working conditions. clean environments, nuclear disarmament, etc.



RESOLUTIONS FROM NAC 1981 ANNUAL MEETING - REPRODUCTIVE FREEDOM

Be it resolved that NAC:

- 1. Adopt action strategies beyond lobbying to implement its resolutions. These would include working with constituted groups and other popular organizations in local areas in participating in educational forums, coalitions, demonstrations, etc., and mobilizing with other forces in appropriate extra-parliamentary action.
- 2. Constitute a committee which will deal with the issue of reproductive rights and the rise of the anti-women and other reactionary groups, and mobilize and coordinate actions in conjunction with other organizations around these issues.
- 3. Endorse the demand of the Women's Constitutional Conference held February 14-15, 1981, in Ottawa, that reproductive freedom be included in the proposed Constitutional Charter of Rights and Freedoms.

FACTS ON CANADIAN NATIVE INDIAN WOMEN

The BNA, Section 91(24) states that Indians are exclusively within the legislative authority of the Federal Parliament of Canada.

- 1970 Federal Parliament enacted the Canadian Bill of Rights. Queen vs. Drybones - courts ruled that Indian Act violated the Canadian Bill or Rights. Drybones had been found guilty before by the Indian Act for being intoxicated off reserved lands.
- 1974 Supreme Court of Canada vs. Lavell Supreme Court of Canada vs. Bedard

5 of 9 judges ruled that the Canada Bill of Rights did not apply to Section 12(1)(b). Lavell and Bedard had lost their Indian status by marrying non-Indians.

- 1977 Canadian Human Rights Commission was enacted by the Federal Parliament.
- 1978 Sandra Lovelace, a victim of 12(1)(b) appealed to the United Nations. Interim decision - the UN recognizes that the relevant Indian Act poses serious disadvantages for Indian Women.

Mary Two Axe Earley of Caughnawaga Reserve, Quebec, is 71 years old and is looking toward the time when she passes on to the other life. Her most pressing fear now is that she will not be buried in her family plot. She says: "It is easier for a dog to be buried on Indian land."

WOODSTOCK — Five Maliseet women have won their appeal of conviction for occupying the Tobique Indian Reserve band council office last May.

In allowing the appeals heard here April 14, Queen's Bench Court Justice Ronald C. Stevenson quashed the convictions Thursday and entered verdicts of acquittal.

Sandra Lovelace, Cheryl Lynn Bear, Glenna Perley, Sharon Elizabeth Paul and Barbara Nicholas were convicted under a new reserve bylaw in Perth-Andover Provincial Court last December.

Each was ordered to pay a fine of \$50, but the women said outside the court at that time they would serve the five day default time in jail and take their children with them — with one defendent adding they could afford neither the fine nor babysitters.

The women were seeking action on housing problems when they went to the band council office a year ago, on the reserve near Perth-Andover. They arrived an hour before noon asking Chief George Francis for a band council meeting to hear their problems, and when employees returned after lunch, the chief told them to work at home for the next three weeks or more.

The women and their children left the office that night, after one band councillor came to talk with them. The new bylaw had been proposed by Chief Francis after injunctions proved fruitless in dealing with sit-ins earlier. In one of the few cases to test the validity of reserve bylaws under the Indian Act. Mr. Justice Stevenson said the Crown failed to present proof that the bylaw was properly enacted or presented to the court in admissable form "and on that ground alone, the appeals must succeed."

Tobique Office Occupation

The appeal judge also found that Crown counsel Daniel Watters failed to prove the Band office had been designated by chief and council for public purposes. He said, however, that he agreed with trial judge T.W. Tomlinson that the band office was in fact occupied, and the bylaw was validly enacted by a majority of the band council.

Defence counsel Paul Janssens said in an interview that he feels "justice has been served," and the bylaw is being amended to provide for "consultation before confrontation," as some band councillors testified they thought that had been the intention all along.

He said the bylaw cannot now be used only to get at certain people, as the defendants alleged during trial. He raised the point of selective prosecution at the appeal, even though it is not a valid legal argument, he said.

But Mr. Justice Stevenson said it is "not up to the court to decide who will be charged, and who will nct. The fact that some are not charged is no defence."

SECTION 12(1)(b) of the Indian Act continues. The Indian women of Tobique continue to face opposition from the Band Council and the Department of Indian Affairs continues to do nothing. PETITION

Since 1869, Canada has practiced legalized discrimination to the Native Indian Women by virtue of the Indian Act, Section 12(1)(b) which states:

- 12(1) The following persons are not entitled to be registered, namely
 - (b) a woman who marries a person who is not an Indian.

This section in the Indian Act denies a Native Indian Woman who marries a non-Indian, her legal title to remain on Indian land on which she was born, and by her exile, she loses legal title to her family inheritance, her choice to be buried in the family plot, and further, she is no longer Native Indian, by law.

We, the people of <u>CANADA</u> petition to the Government of Canada to abolish Section 12(1)(b) of the Indian Act immediately, and to re-instate the Native Indian Women, also immediately, who have had to live in this injustice.

OTTAWA (CP) - The three major federal parties have announced they

tederal parties have announced they support a feminist demand for changes to the proposed constitution-al charter of rights. Liberal, Conservative and New Democratic spokesmen say they sup-port the key demand of women's organizations for a clause saying rights and freedoms are guaranteed equally to men and women equally to men and women. Statements of support by the three

parties for the sexual equality clause were made by Marc Lalonde, quot-ing Justice Minister Jean Chretien, by NDP Leader Ed Broadbent, and by Conservative Leader Joe Clark, a

The demand came from the more than 150 member organizations of the National Action Committee on the Status of Women and from a con-ference of more than 1,000 women organized by the Ad Hoc Committee of Canadian Women, a network of feminists.

The change depends on whether the parties reach a compromise on how to proceed. The Liberals and NDP are accusing the Conservatives of a filibuster — purposely delaying the current constitutional debate.25

They say the Conservatives have bogged the House of Commons down for a month on one amendment and much more delay could drive the government to impose closure, but-ting debate and prohibiting further amendments, including the women's proposals.

However, all parties appear to agree that if there are more amendments, the sexual equality clause will be one of them.
