The NAC Executive Meeting held on the weekend of May 29-30, was a very productive one with all committees organized and well into the year's work. Some committee reports are incorporated within this MEMO.

NAC Vice-President, Jillian Ridington, past executive member Lorenne Clark and I appeared before the Parliamentary Justice Committee on June 1st, 1982. Jillian Ridington (Vancouver) presented the NAC Brief on Soliciting. Lorenne Clark (Nova Scotia) answered questions extensively on Bill C-53. It was interesting that the Committee spent the entire morning on these issues. This is the third attempt to introduce legislation to change the criminal code on sexual assault and there is hope that this bill will now go into committee and be passed before the summer recess.

In 1979 NAC commissioned a medallion to be struck to honour the 50th Anniversary of the Persons Case, a significant legal event for women. A replica had been presented to The Supreme Court of Canada at that time, and on June 4th, 1982, NAC presented Madame Justice Bertha Wilson with the first medallion struck and set aside for the first woman to be appointed to the highest court in the land.

#### PRESS RELEASE May 30, 1982 EXTRA-BILLING - EXTRA DISADVANTAGE TO WOMEN

The National Action Committee on the Status of Women, at its executive meeting today, expressed its concern that at the Conference of Federal and Provincial Ministers of Health in Ottawa on May 26, there was no decision taken to eliminate extra-billing and user charges from Health Services in Canada

Chaviva Hosek, a vice-president of NAC said: "Extra-billing has greater impact on the elderly and the poor, most of whom are women. Women are usually responsible for the health care of their families. Extra-billing and user fees affect women disproportionately." Kathy Coffin, a vice-president of NAC added: "Mme Begin herself has said that extra-billing and user charges threaten accessibility and gradually erode our prepaid health care system. Why did the conference of health ministers not decide at their meeting to eliminate these practices?"

Telegrams have been sent by NAC to all Ministers of Health in Canada, expressing this concern.

NAC is an organization of 208 groups working to improve the status of women in Canada.

## World Beat\_ World Press Review - May 1982

Predictions Futurists, predicting the course of life on Earth, are making newsworthy prophecies, reports Glen Allen in the independent *Gazette* of Montreal [Mar. 15]. Among their current forecasts are:

"The loss of privacy. There will be little about you that your neighbor does not know, little he cannot find out....

"Fewer women in the work force and z great dissent among middle-level... workers. More and more people will be pushed into entrepreneurship.

"An explosion of singles living alone or sharing accommodations in commune-like settings.

"A boom in higher learning, which will be a continuous process for those with time on their hands."

Kimon Valaskakis, a University of Montreal professor of economics, predicts, "In thirty years all of Canada will belong to the [U.S.]....Canada is like a bad party. Everyone's too polite to go until the first guest leaves, then they all leave."

## FROM NAC MEMBER GROUPS

The VOICE OF WOMEN, Toronto, issued a statement on NUCLEAR DISARMAMENT and MILITARY BUILDUPS, which included the following action plan:

- The creation of additional Nuclear Weapon Free Zones by either one country or groups of countries.
- (2) A ban on the production of fissionable materials which could be used for nuclear weapons.
- (3) Agreement for "no-first use" of nuclear weapons.
- (4) Reduction of armaments and armaments budgets with specific plans for conversion to civilian production.
- (5) Much greater allotment of funds for education for disarmament and for productive assistance to developing nations.

They stated, "We women reject our historical role of support for war, the reproduction and nurturing of fighting men, ourselves replacing men in the workforce for the production of armaments, and finally caring for and succoring the wounded, sick, destitute, starving and bereaved victims of war. We are determined that, together with men who work for peaceful solutions to the world's problems, we will compel our governments to take the first concrete steps to reduce tensions and fear by freezing, reducing, de-emphasizing and finally ending the arms race."

"We, The Voice of Women, with women of every nation, want our children to survive so that together we can meet the challenge of providing adequate food, housing, education and health in a safe, just and peaceful world."

Nan McDonald, the Communist Party of Canada's delegate to the NAC 1982 AGM, has called to our attention that a new resolution was being introduced when a quorum count closed the meeting. Following is a copy of the resolution which will go to the executive for discussion at the May 29-30 meeting, along with other resolutions submitted prior to the AGM and which did not reach the floor before the meeting was adjourned.

- 9. Be it resolved that full employment and economic security for women be realized and that the following demands be implemented:
  - a) full employment policies with affirmative action programs for women
     b) guaranteed jobs at equal pay for work of equal value
  - c) equal access to retraining and upgrading of skills
  - d) reduced hours of work with no reduction in take-home pay
  - e) equal access to promotion
  - f) legislative prohibition of plant closures and layoffs
  - g) farm wives to receive a wage for farm work through tax concessions
  - h) access to information on birth control and pregnancy termination
  - i) fully paid maternity leave with no loss of seniority or of benefits
  - j) universal access to comprehensive child care services government funded
  - k) free post secondary education, special courses for immigrant women
  - universal old age pension of \$600/month at age 55 years for women
     mortgage rates to be rolled back
  - n) moritorium on foreclosures declared on homes, farms, small businesses
  - public housing programs, rent controls rents at no more than 25% of a persons' income
  - p) prices on essential foods and energy be roiled back COMMUNIST PARTY OF CANADA

The NAC Executive discussed the above resolution at their May 1982 meeting. It was decided that no further action could be taken until the resolution is reintroduced at the next Annual General Meeting (1983).

Update on Borowski Challenge to Section 251 of the Criminal Code -Canada's Abortion Law



Freedom of choice Liberté de choix

As of this writing, no decision has been made by the Supreme Court of Canada as to where anti-abortionist Joe Borowski can bring his case. Borowski contends that fertilized eggs are persons and deserves the protection of the Canadian Bill of Rights.

In December 1981, the Supreme Court gave him standing to challenge the Canadian abortion law on this basis.

Borowski, a 47 year old Roman Catholic and militant opponent of the abortion law, since it was passed in 1969, resigned as highway minister in Manitoba's NDP government in 1971 to protest the funding of hospitals which do abortions.

Later he went to jail for refusing to pay his taxes in protest against the law. He launched his court challenge in 1979 in Court of Queen's Bench in Saskatchewan, but Federal lawyers argued that it could only be heard by the Federal Court of Canada.

In the summer of 1981, Borowski began a 90 day fast to protest the abortion law. He decided to give up his fast because to fast to the death would be against his religion.

The Canadian Abortion Rights Action League has decided to ask for intervenor status as soon as the case comes to court. CARAL has retained Morris Manning Q.C. to represent the organization in this matter. If Borowski were to win, abortion would be illegal again in Canada. It is for this reason that CARAL considers Borowski's challenge a serious threat. You can help defeat this man by contributing to CARAL's legal defence fund.

## -- CORRECTION --

In last issue "What they said ...", we tossed a brick bat at Svend Robinson (NDP) for asking Acting Justice Minister Bob Kaplan on March 18 to set up a special subcommittee to deal with prostitution. We said that Mr. Robinson knew that this proposal had already been agreed to informally by the Parliamentary Justice Secretary, Jim Peterson, but that Peterson had not yet had a chance to brief Kaplan. Kaplan's response was - predictably, therefore - negative. We said Mr. Robisnon's "unfortunate timing" consequently jeopardized our chances of dealing with this issue separately from the sexual assault issues raised in C-53.

In response, Svend Robisnon called us up and told us that the Justice Committee had not agreed to establish a special committee. Furthermore, before posing his question, he had consulted Mr. Kaplan and obtained an understanding that Mr. Peterson as Parliamentary Justice Secretary would respond to any question on prostitution addressed to the Acting Justice Minister. Mr. Robinson anticipated that Mr. Peterson's response would be at least an informed and open-door one. Mr. Robinson was therefore very surprised and perturbed when Mr. Kaplan answered instead. Mr. Robinson, who is a "Friend of NAC", pointed out that our criticism hurt and invited us to check out his side of the story.

What we've found out is that there appears to be a genuine misunderstanding on the Hill about whether or not the steering committee of the Justice Committee agreed to establish a special sub-committee on prostitution. The Tories say "yes" and even issued a press release on it (later withdrawn); the NDP and Liberals say "no". Through his legislative aide, Mr. Kaplan told us he did not recollect any discussion with Mr. Robinson to let Mr. Peterson answer the question. He pointed out that the record shows the question is clearly addressed to him. To this, Mr. Robinson has responded that his question was addressed to "The Solicitor General while he is still Acting Minister of Justice" and that it would have been quite in order for Mr. Kaplan to indicate that Mr. Peterson, the Justice Secretary, should rise in response.

Many thanks to Svend Robinson for encouraging us to clarify this - and apologies for the hurt.

Just to bring you up-to-date, after much angry- and procedural wrangling, the House agreed to request the Justice Committee to hear witnesses on prostitution. The hearings will, however, be scheduled so as not to impede progress on C-53.



## Bouquets

To Cyril Keeper (NDP) who, on May 14 and 17, pressed the government to account for a memo to C.E.I.C. Affirmative Action consultants in Winnipeg which read in part, "You will not promote affirmative action nor visit employers in this regard. In addition, you will not conduct any seminars or disseminate any information to the field to explain or promote affirmative action." To his credit, the Minister for C.E.I.C., Lloyd Axworthy (Lib), seemed as dismayed as anyone and promised immediate action.

To Justice Committee members Svend Robinson (NDP), Ray Hnatyshyn (PC), and Bud Cullen (Lib), for their close scrutiny of the Canadian Bar Association Brief on Bill C-53 (Justice and Legal Affairs Committee minutes, April 27). Hnatyshyn got the C.B.A. presentor (Greg Brodsley) to admit that the brief - with respect to sexual assault - had only been presented to the Criminal Justice Section of the C.B.A. Robinson further got Brodsley to admit that it had not even been formally approved by that Section. Robinson said Brodsley's presentation "reeks of sexism". Bud Cullen noted the brief represented at most the opinions of 150 lawyers out of 10,000 across the country.



## Brickbats



#### Planned Parenthood - Newfoundland/Labrador

Planned Parenthood Nfld./Labrador has won \$500.00 in damages in its defamation suit against Vera Fedorik, former executive director of the national organization Alliance for Life. This is the first case initiated by Planned Parenthood against an anti-choice spokesperson. We hope that this decision will make anti-choice people more circumspect in their statements. Court costs of between \$12,000.00 -\$15,000.00 are anticipated.

In the summer of 1980 Planned Parenthood issued a writ against Vera Fedorik and the St. John's Right to Life Association asking for a public apology and a retraction of statements made about Planned Parenthood Nfld./Labrador in the spring of 1980. Supreme Court Judge Noel in his judgement dated April 1982 said that the things which Vera Fedorik said in the magazine Atlantic Insight and on an open line show implied that Planned Parenthood provided sex education films for teenagers that were pornographic and that we presented sex education in such a way as to cause a steep rise in the illegitimacy and abortion rate for teenagers and these words were found to be false and defamatory; that is the words would tend to lower Planned Parenthood in the estimation of right thinking members of society or to expose it to hatred, contempt or ridicule.

Ms Fedorik was employed under a grant from the Grey Nuns to Valade Vitae Services to organize and coordinate the activities of anti-choice organizations in Nfld. But as she was neither an executive member nor an employee of the St. John's Right to Life Association, the judge said she did not speak for the Right to Life Asso. The case against the St. John's Right to life Asso. was dismissed with us paying five days of their court costs.

At a recent conference in Solidarity with the Liberation Struggles of the Peoples of Southern Africa, it was stated that the white minority South African regime has intensified its repression of the black majority within and close to its boundaries.

- Seek to establish closer contacts with the ANC and SWAPO Women's Section recognizing that the oppression of women is an integral issue to be addressed in our solidarity work.
- Promote and sponsor cross-Canada tours of women speakers from ANC and SWAPO.
- 3. Promote the celebration of August 9 as the Day of Solidarity with the Women of South Africa and December 10th as the Day of Solidarity with Namibia in accordance with the U.N. General Assembly Declaration.
- On March 8, International Women's Day, include solidarity with ANC and SWAPO women.
- 5. Organize material aid campaigns for the special needs of South African and Namibian refugee women and children.
- 6. Demand the release of all women political prisoners in Namibia South Africa.
- 7. Organize to provide aid for the families of all political prisoners and detainees.






