Legal Counsel for Unborn

Opposition to freedom of choice for women continues. On January 17, Lawrence O'Neil MP for Cape Breton Highlands-Carso (Nova Scotia) introduced Bill C-254 "an act to amend the Criminal Code to provide legal counsel for the unborn child" for a second reading. Fortunately after Margaret Mitchell (NDP Vancouver East) argued against this ridiculous bill, it died on the order paper. Then, on Monday January 20 another private members bill which sought to eliminate all abortions except where the mothers life was in danger was given second reading. Jim Hawkes (PC Calgary West) spoke at some length to the bill but "it was not possible to determine where he stood". Letters from ASWAC members to the honorable member, House of Commons, Ottawa, might help him to clarify his position further.

CHILDCARE UPDATE Out-of-school care struggle

The Emergency Ad Hoc Group on Out-Of-School Care, of which ASWAC is a member, is cont-inuing to meet to discuss provincial funding. After a bar-rage of lobbying the province to put additional dollars into Out-of-School Care programs, we have few assurances of anything. The city of Edmonton decided to keep all the children already in the program but upped the basic fee (for those on full subsidy) by \$20 to \$60 per month. Neil Webber indicated several times that chances were good F.C.S.S. funding would be increased which would give all municipalities more dollars for Out-Of-School Care Programs. Webber however, was moved to Education and has been replaced by Connie Osterman

Federal Hearings

The Special Committee on Child Care is holding hearings across the country in the next few months and will be in Alberta between June 2 and 6. The Committee, made up of federal M.P.s, will hear witnesses in Calgary, Edmonton and Medicine Hat. Reasonable travel and accommodation costs will be paid to enable groups from other parts of the province to attend. All requests to appear before the Committee should be sent to Ottawa by MARCH 14.

Submissions may be sent to the Committee at any time prior to June 2nd. All correspondence should be sent to the Special Committee on Child Care, Suite 308, 151 Sparks St., Ottawa KIA OA6; Tel. (613) 995-3789.

ASWAC is interested in knowing who, in Alberta, will be making presentations and/or submitting briefs. Please send us a copy of your presentation or contact the office. whom we have no reason to believe is sympathetic to increased funding for child care. F.C.S.S. funding from the province has been frozen for three years and we can hardly believe that this can continue, particularly since this is an election year. However, we can't afford to take any chances and will continue to inform and pressure the government.

Municipal Recommendations

INTER-MUNICIPAL 1ASK FORCE REPORT ON OUT-OF-SCHOOL CARE

- That, in consultation with Municipalities, the Province be requested to immediately raise its F.C.S.S. program base allocation for all municipalities to at least \$12 per capita, plus an inflation allowance retroactive to 1982 that accomodates true cost of living increases and further that this resolution not be constructed as contrary to the F.C.S.S. Association's resolution calling for a "substantial increase".
- 2. That, in order to provide a long-term solution to the Out -of-School Care issue, the Province, in consultation with Municipalities, be requested to establish a seperate funding "element" for Out-Of-School Care, with the basic F.C.S.S. philosophy, guidelines and administration, under the 80% 20% formula, but which would be open-ended and drawn on by Municipalities depending on the need being experienced within the local jurisdiction.
- 3. That the licensing and monitering of Out-Of-School Care programs be a joint responsibility negotiated individually between the Province and Municipalities. If a municipality wishes to license and moniter Out-Of-School Care programs which operate within its jurisdiction, the Province should delegate that responsibility along with appropriate funding. If the municipality does not wish to be responsible for these functions, it would ask the province to do so but in accordance with the licensing standards approved by the municipality.
- That both the Province and Municipalities adopt as their guidelines for licensing Out-Of-School Care the policy statement on Out-Of-School Care Standards.
- That joint responsibility for Out-Of-School Care be clarified in the Social Care Facilities Licensing Act.

Vigil for Brenda

On Wednesday, January 29 about 300 Edmontonians gathered at a Candlelight Vigil to commemorate victims of sexual violence. The vigil was organized by the Edmonton Sexual Assault Centre and ASWAC in response to the discovery of Brenda McClenaghan's body and the reaction of the public to her murder.

Brenda was abducted from a parking lot in Edmonton earlier in the month and the search for her ended in horror. The vigil, new conference and media work centered on our outrage at these kinds of events, our grief for Brenda's family and friends, and for others with similar experience of sexual violence.

The vigil included speeches, a song written by a S.A.C. volunteer, a poem written and read by an ASWAC member and the lighting of hundreds of candles. The decision to organize the vigil came from the many calls received in the two offices from people expressing their anger. The message to the people at the vigil, and to others through the media was clear. Women have an equal right to safety in our streets, public places and homes. Women cannot be kept - and will not hide - in private, so called safe places. We will band together to enjoy our rightful places in the world. And we will not accept any compromise from politicians, news writers or the judiciary in erradicating the injustice.

Tackling the Member issue

One of the areas ASWAC will be working on this year is membership. It is important that we continue to grow so that we remain a strong, common voice for women's rights in Alberta. Two issues require policy decisions: male membership and group versus individual memberships. We hope to hear what you think.

At present, both women and men may purchase a membership in ASWAC and attain full rights in the organization. In developing a male membership policy a variety of options should be considered. Three such ideas are outlined below but you may have more alternatives.

1)maintain the status quo allow male members the same rights and privileges as female members.

2)establish associate membership for men - whereby they would receive the Newsletter and have access to services through ASWAC. This type of membership could mean that



they would not have a vote at meetings; nor could they sit on the Board, nor attend the General Assembly.(A combination of the above is certainly possible).

3)not allow men to attain ASWAC memberships.

When determining a male membership policy, a number of factors should be considered. These include; the affect of men's active participation in ASWAC, the public's perception of the policy, the impact the policy could have on potential members.

The second issue requiring a policy decision is group membership. At present a number of local, provincial and national organizations purchase ASWAC memberships each year. While this provides for communication between women's groups and groups organized for social change, it can have a detrimental effect on ASWAC's overall membership. Individuals who may otherwise become a member of ASWAC may feel they are sufficiently represented by the organization they are affiliated with. Therefore they do not join ASWAC. This leads to the question, Why join ASWAC? Of course there are the fringe benefits of receiving a regular Newsletter and the right to vote and attain a position on the board. However, one of the most im-portant reasons to join ASWAC is to ensure one common voice for Alberta women-gaining strength through numbers to enable ASWAC to demand more

positive changes for the women in this province.

ASWAC could separate group from individual members in one or more of the following ways.

 charge a higher membership fee for groups. One major concern is that many of these organizations are non-profit and already strapped for funds.

2)count the membership of member organizations as members of ASWAC. This may create double counting and, raises the concern that all members of one organization may not necessarily Wish to be included in another.

3)encourage individuals within their organizations to take an individual ASWAC membership.

ASWAC could use a combination of these points or develop our own group membership policy.

If you are interested in contributing your suggestions or concerns on these issues, please foward them to me, Aura Rose, care of the ASWAC office by April 11, 1986. The policies will be presented for final approval at the General Assembly in November. Thanks alot for your input!



Advisory Council

The long sought provincial advisory council or Alberta Council on Women's Affairs should be announced before the provincial election. The Provincial Committee that has been lobbying for the council has had some assurance from Mr. Johnston that the mandate and structure of the council will be accepted as proposed by this same group.

Now is the time to submit resumes to Mr. Johnston should you wish to be appointed to the council. Resumes should be sent with a covering letter to the Hon. D. Johnston Minister Responsible for the Status of Women, 127 Legislature Bldg., Edmonton. A copy of the proposed structure can be obtained through ASWAC.

59¢ day committee

Early in November, 1985 information began to surface which showed that many women's groups were encountering financial difficulties due to cutbacks and delays in funding provided by the Secretary of State Women's Program. Furthermore, political lobbying by antifeminist groups was threatening the very existence of the Women's Program. A meeting was held Nov 16, 1985 attended by approximately 25 women expressing individual and agency concerns over the funding problem. Three approaches were recommended. Individuals and agencies would write to and meet with federal representatives to state their concerns and the value of Secretary of State funding. A recommendation was sent to the National Action Committee conference to sponsor provincial information days to celebrate the work being done and to inform politicians and the media of the cutbacks. The 59¢ Day Committee was struck with a mandate to strategize other possible courses of action.

The committee met thr Oughout November and December with members reporting on contacts made to inform politicians of the situation. Little sympathy was forthcoming. The NAC recommended that actions be organized on a provincial and local level. A presentation was made at the ASWAC assembly to inform members around the province of the situation. Representation at the meeting remained focussed in the Edmonton area.

Discussions were held to develop strategies for resolving the funding crisis. Suggestions included the establishment of a private sector foundation that would request matching goverment funds; working together with women in political parties, particularly the

Conservative party, to develop a political profile; and public workshops to coincide with International Women's Day that would draw public and media attention.

By January 1986, the inmediate crisis situation had altered. With the exception of the Newsmagazine for Alberta Women, the affected agencies had received some, if not all, of the funds budgeted by the Secretary of State. The 59¢ Day Committee took stock and began to extend its mandate. The focus of discussion shifted toward examining long range planning, including not only funding sources, but also general visions of the future for women's groups.

An idea formulated around conducting a workshop on 'Futures' that would bring together women's groups to discuss such questions as:

1) How might you envision your organization in five years?

2) What problems or concerns would you anticipate for that time?

3) How might a coalition help your organization in strategizing for the future?

At our first meeting in January, we appreciated that our mandate had shifted and that the focus established in November, 1985 was fading. It seemed appropriate to recognize that, to report back on our process, and to encourage ASWAC members to

Women's Centres to meet

ASWAC has organized a women's centres conference for March 15 and 16. The conference is open only by invitation and between forty and fifty participants are expected. Some of the women will be from towns where women's centres are in the process of being established: Fort McMurray, Fairview and Westlock. This will be an opportunity for them to gain from the experiences of established centres. This is the first conference for women's centres in Alberta which is why we are limiting the number of participants. The response has been quite overwhelming though, and we

are encouraged to hold a much larger conference within the next year.

Six workshops have been organized: goals clarification, using media, funding reaching out to new women, building boards and collectives and things in between, and women's centre as crisis centre. The conference is being held at the Edmonton Women's Building and local ASWAC members are invited to join us there on Saturday evening for a great party. For details, please contact Frances at the ASWAC office. consider the possibility of 'futures' strategizing. Short of creating new work for ourselves, we might conclude here. However, the concept of developing a workshop directed at 'Future Visions' is an exciting one, and we believe it might fit well with the ASWAC Assembly. The committee is willing to discuss these ideas with the ASWAC Board.

It is timely to conclude with news of the freezing of federal funding for projects across Departments announced in February 1986. It is apparent that the work has only just begun...

Law imposes hardship for women

If you are a woman living in Canada, you lost some of your civil/human/constitutional rights on December 20, 1985. Your freedom of movement and freedom of association have been restricted.

How did this come about? In the form of Bill C-49.

Prostitution is not illegal in Canada, but this bill has made waving, winking, talking, gesturing or any type of communication which may be interpreted by police as soliciting for the purposes of prostitution illegal.

Prohibition has never stopped an activity, merely driven it underground. Once out of the public eye, it becomes more dangerous for participants, more open to abuse. The government has given a clear message to men in Canada that they do not care about the safety of women by making it harder for prostitutes to report violence against them. Trying to legislate morality does not work either. If a woman who works as a prostitute flags down a friend while not working, she could be charged under this new law. If she retires, is she never to be able to stop on the street to speak with a friend? Get into a car with a friend? Once a prostitute.

always a prostitute?

This is unfair to all women, not only to those who currently work as prostitutes.

Bill C-49 condemns all behaviour associated with prostitution including casual sex, frequent sex, and sex outside the home - and is therefore an attack on the sexual freedoms of all women.

An infringement of one person's rights, is an infringement of all people's rights. How can we make every day movements illegal for only a certain segment of the population? We have returned to the days when women aren't allowed to be on the streets unless they can give a good accounting of themselves; where they are going, what they are doing there, how they earn a living. This law imposes increased hardship and violence against women who work as prostitutes.

Porn Action Succeeds

Efforts by concerned people who live and work in the McCauley-Boyle Street area of Edmonton to oppose the establishment of a business by "Erotic Video Exchange" in the neighborhood have met with success. Led by the group "Positive Action Against Pornography", "Ukrainian News Publishers", and others, the group petitioned the Development Appeal Board of Edmonton City Council on January 23. 1986. Arguing on various grounds including the concern that children would have to pass by the store on their way to school, and that the business would not be in keeping with the McCauley-Boyle Street Area Redevelopment Plan (whose aim is to create a healthy community), the community group worked to persuade the Board to oppose the pornographic video store. The board voted unanimously to reject the application for a permit.

It should be noted that the availability of pornography was challenged by citizens without using the courts or the Criminal Code of Canada. The case demonstrates again that collective actions by concerned individuals on issues relating to the oppression of women CAN WORK.
