native indian women

A meeting is planned for March 9 of all the First Ministers and the Prime Minister. Aboriginal Rights is an issue on the agenda. We have heard that the federal government is prepared to give the natives of Canada some form of self-government. If that happens, the Indian Act, which is an act of the federal government, will no longer apply.

We have lobbied for the repeal of Section 12(1)(b) of the Indian Act for many years. 12(1)(b) says that any woman who marries a non-status Indian loses her status as an Indian (the same is not true for men). We have also lobbied that children born of such unions retain their Indian status.

We have it on good authority that the federal government, in offering some form of self-government to the native population, will not require the reinstatement of Indian women and children to Indian status and will leave it up to individual Indian governments on how they treat the question of status for Indian women.

Action .. Urgent .. Action

Please telegram/telephone the Hon. John Munro, Minister of Indian & Northern Affairs -- and Prime Minister Trudeau -- INSIST THAT IT IS UNACCEPTABLE TO GRANT INDIAN SELF-GOVERNMENT WITHOUT STATUS EQUALITY FOR INDIAN WOMEN AND THEIR CHILDREN.

pensions

At the time of her divorce, Joy Irving did not know of the possibility of sharing pension credits. When she heard of the provision she applied immediately. Unfortunately she applied 25 days after the three year eligibility period. Her claim was denied. She applied to the Minister of Health & Welfare, Monique Begin, who denied her appeal. She then filed an appeal under section 83 of the Canada Pension Plan Act. The Review Committee decided in Irving's favour, but Begin appealed this decision to the Pension Appeals Board.

The Equal Pay Information Committee is mounting a public campaign to change the law regarding pension credit splitting upon divorce and at retirement, making the splitting automatic and mandatory. They feel this can only be done with cooperation from women's organizations across Canada. You can help by publicizing the case in your newsletter, at meetings, and by your contacts with the media. A labour code for women

In the December 8 Throne Speech, the federal government unveiled proposed changes to the Canada Labour Code. WOMEN'S NEEDS WERE IGNORED. Instead of action to end discrimination against part-time workers, the federal Minister of Labour, André Ouellet, is proposing further consultations. Since 1979 the Liberal government in Ottawa has been consulting and promising. We need action NOW to legislate equal pay rates and proportional benefits for part-time workers, 75% of whom are women.

Also conspicuously absent from proposed amendments are provisions to require more frequent rest periods for workers using video display terminals. When questioned on this issue by a journalist from LA PRESSE, Mr. Ouellet responded that the existence of health problems has not been verified. If all the studies done have not convinced Mr. Ouellet, then perhaps he's listening more to employer groups than he is to Canadian women.

Since 1976 the NAC has been passing resolutions on part-time workers. Last year's AGM called for legislation to deal with health problems created by Video Display Terminals. The time has come to mount a grass-roots campaign. In a pre-election period when the Liberals are looking for issues which will make them more appealing than the opposition, concerted pressure can make the difference.

In December, NAC member groups were asked to send telegrams to Mr. Ouellet. We urge those who may have been missed to send their telegrams immediately, insisting on pro-rated wages and benefits for part-time workers and a restriction of 40 minutes per hour worked on VDT's. Send to:
