Article 5, con't

The per capita received by the Council will be divided equally between the George Burt U.A.W. Education Centre and the General Council Funds.

- B. Per Capita payments shall be made to the Secretary-Treasurer of the Council who will deposit funds in a bank account as agreed by the Executive.
- C. The Secretary-Treasurer shall be bonded by such sums as established by the International Union.
- D. A quarterly Financial Report will be issued to the Delegates.
- E. The Council Trustees shall audit the books at least quarterly and report to the Council.
- F. Delegates authorized to carry out Council business shall be paid an expense allowance of \$55.00 per day when away from home and an expense allowance of \$15.00 per day shall be paid while in their own community. While on authorized Council business, members shall be compensated at not more then 8 hours per day or 40 hours per week at their regular hourly rate.
- G. The Secretary-Treasurer shall be compensated up to three days after each Council meeting to complete correspondence and prepare the minutes for publication.
- H. Mileage allowance for auto transportation will be 20¢ per mile.

ARTICLE 6 - VOTING PROCEDURE

- A. Only accredited delegates shall have voting rights.
- B. Each delegate shall be entitled to one vote except on roll call vote.
- C. Roll Call votes shall be taken when requested by fifteen delegates, and for the election of Officers of the Council. Voting strength of each Local will be according to voting strength of last Convention.
