NSWC RECEIVES \$16,000

Much has been happening at the Women's Centre these past few weeks. After we received a rejection notice of our L.I.P. grant application a few members arranged a meeting with James McGrath, the MP for St.John's East, to find out why, in International Women's Year, a project for women was rejected. The fruits of politicking paid off when, on February 1st, Shirley Goundrey received a phone call to say that money had been found. We would receive our \$16,000 grant! The amount allowed us to employ 4 full time and one part time person to work on various projects. It was decided that more would get done if we could have nine part time workers to share the workload. Many hours of phone calls and talking have brought together a formidable team!

Ellen Antler and Diane Siegel will be setting up Women's Study courses;

Loretta Kelly and Jill Schooley are working in the areas of self-help;

Jean Chadwick and Shirley Goundrey are heading the Social Action areas; and

Celia Griffiths and Mary Walsh will act as Secretary-Directors to co-ordinate the project and staff the Centre; and Joyce Flight is our Bookkeeper, and will help in the Centre.

WE ARE MOVING

All of this activity has meant that a new centre should be found. One with a better landlord, unfrozen toilet, adequate heating so we don't have to type with our gloves on, and more space. As of the 15th of Feb ruary the new Women's Centre will be at 77 Bond Street, just a block down the hill from Rawlin's Cross, in the old Bishop Spencer school. If anyone can donate furniture, shelves, etc. please come to the Centre and see what is needed. Anyone wanting to know in more detail what the project workers' duties are, please come and ask, they are too numerous to list here.

THE MORE WOMAN POWER THE BETTER

To capitalize on our new opportunities, the result of funding and larger quarters, we are going to be calling on many of you. Hopefully, you'll be contacting us, too. The on-going activities of the Women's Centre include referral services, the lending library, the various committee activities, the Newsletter undertaking and all the secretarial work to do with running a Status of Women Council. The funds for these activities and for our new quarters (the rent is double) are still the memberships responsibility. So you can see how much we still need your active involvement and financial support.



IWY Radio Commercial Taken to Task

OFFICIAL TAXPAID COSMETIC HIPPOCRACY

The above title is my reaction to one of the Women's Year radio commercials. The one I'm most incensed about proclaims the importance of being a housewife. My reaction is not to the idea that homemaking is unimportant. The function of maintaining family life support systems is vital. Maybe if we thought of it as the maintenance of physical and psychological life support systems instead of housewifing or home making we would begin to realize just how important homemaking is.

Then what am I enraged about? The Cosmetic Hippocracy is in the context of the Murdock decision that did not recognize the contribution of a farm wife, who not only maintained the home but also worked in fields and barns, as being worth anything when the marriage broke up. If you are a female your contribution to the accomplishments of a family usit is apparently worth nothing beyond your ordinary living expenses while you are a wife and some maintenance and maybe alimony after a divorce. All of the benefit in law from accumulation of property and worth is assigned to the husband. wonder what the decision would have been if two males had been involved say two brothers?

If they want to have commercials about how important it is being a housewife - fine. But that same commercial should come down hard on the fact that our culture doesn't recognize these vital contributions.

In the words of their own ad writers - WHY NOT!!

WOMEN AND POLITICS

Rosemary Brown to run for national leadership in NDP Party.

Former activist in the B.C. Status of Women has announced she will be running for the leadership of NDP. Rosemary Brown is spoken of highly by Newfoundland Status of Women who have seen her in action at conferences.

When asked if she was running as a woman, a black or a socialist she declared, "a socialist," and didn't mince words about it.

Times are a changin', at least in B.C.

The Evening Telegram of Jan.23, 1975 carried a news item concerning the speech made by NDP MP, Ed broadbent on the occasion when the Commons was taking time to allow its members to pay tribute to IWY.

Mr. Broadbent urged women to "keep the heat on" politicians. No group had ever won liberation by relying on the efforts of others.

He called for legislation to end end sex discrimination in the job market,

establish 24-hour child-care centres, enforce equal pay for equal work,
guarantee collective bargaining for domestic and part-time workers,
ensure equal educational opportunities for male and female students,
eliminate sex stereotyping in text books, outlaw sex exploitation in advertising

- give men and women equal pension rights, remove abortion from the criminal code, and establish sex education and birth control centres.

If the government is serious, it should start by introducing legislation in these 10 areas, he said.

THE INTERNATIONAL IN I.W.Y.

What about the lot of women in other countries? The Jan.Feb. issue of BRANCHING OUT has a lengthy article based on a trip by Gwen Matheson to the Soviet Union. Here are a few quotes from the article to whet your curiousity.

"...40% of Soviet lawyers are women...40% of the Supreme Soviet of the USSR, I have been informed, is composed of women....There was the editor of the Publishing House of Artistic Literature, Leningrad Brance, who told me,...that they reject pornography because 'mental food must be as good as physical food.'

From my observations of Soviet women, however, I have come to the general conclusion that the amazing accounts of their liberation are indeed true. Economically, professionally, and politically they are so far ahead of women in North America that it becomes a fact painful as well as inspiring to contemplate....

This remarkable phenomenon of the advancement of women dates, like almost every other form of progress in the Soviet Union, from 1917 and the October Socialist Revolution..."

(We plan to report on women from other countries in future issues. First hand accounts from one of our readers would be very acceptable.)

AND ANSWERS

Section 251 of the Criminal Code forbids Abortion except when in the opinion of the therapeutic abortion committee of an approved hospital, "continuation of the pregnancy would or would be likely to endanger her (the woman's) life or health."

Because the law is not being applied fairly. What we really have is "Legal Abortion with Obstruction". Some hospitals and doctors who have been trying to serve the public within the law have been picketed and intimidated. The World Health Organization says: "Health is a complete state of physical, mental, and social wellbeing and not merely the absence of disease or infirmity." Most hospitals do not apply this definition. Women who are wealthy or know their way around can usually obtain abortions. Women who are poor or who live outside the larger cities are frequently refused or forced to travel great distances. Turning a desperate woman to a quack abortionist certainly endangers her life or health.

No - we regard any abortion as an indication of failure. Failure of health, Failure of education, Failure of birth control. But until such failures can be reduced and eliminated, women pregnant and in distress must have the freedom of choice.

Abortion is an important matter which each woman must decide for herself, in consultation with her doctor. She may want guidance from her family and even from her church, but surely not from politicians or the police.

Then we read: "Newfoundland is a poor province, its people among the poorest in Canada, the butt of Canadia jokes. Though the value of minerals produced here, per person, is more than double the Canadian figure, yet the average Newfoundland income is less than 60% of the average Canadian income.

The unemployment rate in June exceeded 20%.

The total debt of the province has reached \$1,563 million - almost \$3,000 per Newfoundlander."

In the introduction the author says:

RESOURCES ARE NOT: THEY BECOME

Mineral deposits, forests, waterfalls, schools of fish; these become natural resources when man discovers how to shape them into things he needs. Today, in the industrial countries of the world, raw materials from nature are shaped by complex technology to meet, and create, a bewildering variety of needs. Increasingly, those who own the machines that shape our natural resources are producing luxuries for the already rich. And doing so when the size of human need is growing, and for the first time in history, the possibility arises of terminating civilization by exhausting the natural resources on which it is based.

We need, and have a right to, useful jobs and decent incomes; fair treatment and fair opportunity; good health care and good housing; access to the cultural wealth that allows us to grow in freedom and intelligence. Intelligent use of natural resources can help us meet these needs, but there are few parts of the world where resources are so used. The economic systems for putting natural resources into use and distributing the value thus liberated benefit a few people, often millionaires, at the expense of millions of poor. So it has always been. Now, the yawning chasm between rich and poor in this world has grown to frightening, unbearable proportions.

RADICAL FEMINISM

Some Male Responses

Anne Koedt

Here are some male reactions commonly heard when talking to men about women's liberation. They must be pointed out and exposed for what they are, so that they may no longer have the effect of keeping women's consciousness down.

THE LAUGH: Dismissing the issue without even discussing it. This puts all the burden of proof on you.

YOUR FAULT: It's your personal problem. Not a social, political one. "Something in your life must have screwed you all up so you hate men. See a psychiatrist." This is the technique of trying to isolate you.

WOMEN ARE "DIFFERENT": The "separate-but-equal" argument based upon biological data. "You're not inferior, just different. I love women." This technique uses physiology, which obviously cannot be changed, as proof positive of the validity of the status quo. Most oppressed groups in the world have some physiological argument tacked on to them.

WOMEN'S RIGHTS WERE WON 40 YEARS AGO: Recognizes the problem as a past one, but denies that it still exists.

THE MALE LIBERAL: "I'm all for it, but what about the children, etc." The technique works to agree there's a "problem", then tries to steer you back to the traditional role by specific guilt manipulations.

THE SUPER-FEMINIST: Having accepted the issue superficially or actually, but still needs to one-up you. So he becomes the super-feminist, moralizing to you about how you haven't quite made it yet, etc. Helping the little woman with her problem. This maintains control over the process and also intimidates the woman.

SEDUCER: Having been unable to argue or intimidate the woman, he trics to re-establish the conventional role by having sex with her. It's a conquest. This area is very subtle, since he may agree with you verbally, may recognize you as a formidable, strong woman, etc., but that just makes the conquest all the more challenging.

WOMEN DON'T WANT FREEDOM: The oppressor turns on the oppressed, blames her for her own oppression. Since one can always find Aunt Toms, scared women, etc., this argument can seem real if one does not distinguish between who is the vistim and who is the perpetrator.

I'LL ACCEPT WOMEN'S FREEDOM IF...WOMEN WILL GO TO VIETNAM, PAY ALIMONY, etc.: This is a very intimidating tactic because it is a threat that if women want to free themselves the few privileges they have will be taken away from them.

SHE'S ONLY A FEMINIST BECAUSE SHE'S A BITCH WHO CAN'T GET A MAN: And you don't want to be like that, do you? Third-person tactic used to persuade women that the worst thing that could happen is to lose their oppressors.

I.W.Y. Programme Proposal: prepared by Newfoundland Status of Women

This is an outline of a grant proposal to the federal Secretary of State for I.W.Y. funds. This project will demand a lot of help from the general membership if we are given the go-ahead signal.

It is our aim for International Women's Year to demonstrate to the general public all areas of discrimination women encounter throughout life. To do this we shall make use of the media and set up displays of literature pertinent to the women's movement in and around the city of St. John's. Our main priority will be to involve Junior and Senior high school students with a view to raising consciousness regarding the changing role of women in our society and the effect on our established institutions.

During the months of April - June, September - December, exhibits will be set up in schools displaying literature on women's issues. There will be eight displays, each on a different theme, eg. image of women in the media, sexism in textbooks, history of the suffragette movement, etc. These displays will be rotated around the schools and Trades Colleges each month and students will be invited to take part in discussions on each theme. Films and other audio-visual materials will be used.

These same displays will be set up in public buildings, eg. libraries, government offices, city hall etc., during the summer months. Response from the public will be invited.

As well as the literature exhibits and talk sessions with students, we would like to use monthly advertisements in major provincial newspapers to draw attention to the same issues as in the displays. An accompanying press release will discuss the subject further.

We feel that this project will increase the awareness of women's problems in society and help some people along the path towards an equal existence.

ON WOMEN'S LIBERATION

From Lu Hsun's Writings

Chinese Literature No. 9, 1973.

Confucius said: "Only women and low-class men are hard to keep. If allowed to approach you, they show no respect; if kept at a distance, they complain."* Here women and low-class men are lumped together, but there is no knowing whether this included his own mother or not. Although the later orthodox Confucians have always treated their mothers with a show of respect, those women who are mothers in China are still slighted by all men who are not their sone.

After the 1911 Revolution, ** in order to have her share of political power, the celebrated Miss Shen Pei-chen*** kicked over a guard at the entrance to parliament. Only I have a strong suspicion that the guard fell down himself, and that if one of us men had kicked him he would have kicked back several times. But this is one advantage of being a woman. Again, certain married ladies today can stand beside their plutocratic husbands to be photographed with them on docks or in conference halls; or before the launching of some steamship or aircraft they can step forward to smash a bottle of wine. (This may be the prerogative of unmarried ladies: the details are beyond me.) This is another advantage of being a woman. In addition, there are various new professions. Apart from women factory workers, whom the bosses like to employ because their pay is low and they do as they are told, in the case of others, although they are described as "flower vases" we often see the honourable announcement: "You are served by an all-female staff," and this no doubt is just on account of their sex. If men want to soar to such dizzy heights, to rely simply on being masculine will not do; they will have to turn into dogs at the very least.

These are the achievements since the May 4th Movement**** and the campaign for women's liberation. But we often hear the bitter lamentations of professional women and the gives of critics at the New Women. By stepping out of their boudoirs into society, they have in fact supplied new material for general gossip and jokes at their expense.

This is because, although in society, women are still "kept" by others. If others "keep" you, you have to allow them to scold you or even insult you. We have seen how Confucius scolded, and know that was because he found women "hard" to "keep", neither keeping them "close" nor keeping them "at a distance" proving entirely satisfactory. This is the complaint of most male supremacists today. It is the afflication of most women too. Until the dividing line between "keeper" and "kept" is done away with, there can be no doing away with these complaints and afflictions.

In this still unreformed society, every single new fashion is just so much window-dressing. In point of fact nothing has really changed. If you take a small bird which has been caged and let it perch on a pole, its status appears to have changed; but actually it is still the plaything of men, at the beck and call of others. This is what is meant by the proverb: Accept a meal and accept orders. So before all women win the same economic rights as men, I regard all find-sounding titles as empty talk. Of course, there are biological and psychological differences between men adn women, as indeed there are between members of the same sex; but their status should be equal. Only after their status is equal shall we have real women and real men and do away with complaints and afflictions.

ON WOMEN'S LIBERATION (Cont'd)

Before true liberation there will be fithting. I am not saying, however, that women should take up arms like men or suckle their infants with one breast only, leaving the other half of the responsibility to men. All I mean is that we should not rest content with the present temporary situation, but fight unceasingly for liberation in the realm of ideas, the economy and other fields. When society is liberated, we ourselves will be liberated too, But of course it is also necessary to fight against present-day fetters which are exclusively women's.

Never having made a study of women's problems, when constrained to express my opinion on the subject these few idle words are all I have to say.
