This year's annual membership meeting was held May 30th at the Senator Motor Hotel. Last year's steering committee decided that a dinner meet ing would be a nice change... and so, we drank a little cheer, we ate a lot of good food (there were a lot of second helpings of the Black Forest Cake!), and yes, we did talk business.

The following amendments to By-Law I were passed at the meeting:

- 1. Article II, Section III was amended to read, "Twelve members, two of whom must be elected members of the Steering Committee, shall constitute a quorum for a General Membership meeting. Four Steering Committee members shall consitute a quorum for a meeting of the Steering Committee
- 2. Article V, Section I was amended to read, "There shall be a Steering Committee made up of 7 members elected by the membership at the annual meeting pursuant to the provisions of Article II".
- 3. Article V, Section V was amended to add the following:
 "(f) Member-at-large;"
 (g) Member-at-large;"
- 4. Article V, Section VII was amended to read as follows: "A request for resignation of a Steering Committee member must be given to the Steering Committee member, in writing, two weeks prior to a General Membership and must be accepted by a 2/3 majority vote of those in attendance. The member making this complaint must give notice of the complaint and of the upcoming General Membership meeting to all members."

"WHY ME?


Even though my first degree was in Fine Art (Ottawa U., 1974), I've always been involved in some fashion, with health issues— until I finally took the plunge into the BScN program (that's a Science Degree in Nursing) at Laurentian U. I'll be graduating in the Spring of 1984, ten years after my first degree!

WHERE TO BEGIN?

Begin at the beginning, as my mother always said. Most women have scanty knowledge and therefore minimal understanding, of the internal workings of their reproductive systems. Doctors don't seem to have time to do much more than poke and prod. They aren't there to teach us, they're there to stop us from getting sick or to help us get well. At least that's what they're taught.

TAKE THIS DIAGRAM and imagine it super imposed on your body below your navel. (What the doctor always calls "your belly-button")

Sometimes (if you aren't on the Pill), in the middle of your menstrual cycle, you'll feel a small sharp cramping pain on one side or the other. This is ovulation, or the egg exploding from one ovary, on its way to fertilization (if there's any sperm handy) or to disintigration occurs in about 14 days.



Interestingly, most women either menstruate or ovulate around the Full Moon. Not too strange - we're mostly salt-water-just like ocean tides! See um - Pose Maria

Ce bouquin publié par la Fédération des Femmes canadiennes-françaises se veut "une collection de témoignages des femmes francophones ordinaires sur leur vie". Les recherchistes ont travaillé pendant un an à recueillir près de 500 témoignages ou biographies de femmes francophones hors-Québec: femmes pionnières qui, entre le travail de la maison, le soin des enfants, la couture et le train des animaux, ont trouvé le temps de s'occuper des enfants, d'être sage-femme ou enseignante, et de transmettre les valeurs culturelles francophones.

La participation de ces femmes dans leurs communautés croissantes n'a jamais été reconnu; on ne parle pas d'elles dans les livres d'histoire, on n'érige pas de monuments; on les oublie.

Comme aujourd'hui, la valeur de la femme au sein de sa communauté est restreint à la valeur qu'on lui accorde au sein de sa famille: une femme est soit "la mère de" ou "la femme de" (de fait, la sémantique ici reflète bien notre perception de la réalité; c'est comme dire en anglais Mr. Smith's woman").

Les témoignages choisis pour la publication dans ce bouquin sont à la fois tristes et pleins de joie: tristes parce que ces femmes parlent de misère, de travail long et ardu, d'injustice; pleins de joie parce qu'elles parlent de fierté, d'amour, de folie. Voici donc quelques exemples de ces témoignage

"Quand je suis arrivée, y'avait pas beaucoup de de français, mais moi j'ai pas eu de misère parce que je restais à la maison pour élever mes petits. Ca fait que c'est mon mari qui faisait toutes les commissions. Puis lui y connaissait la langue un peu parce qu'y était déjà venu. J'me souviens y'allait au magasin m'acheter des robes des fois... c'était pareil avec mes chaussures. Aujourd'hui on fait pas ça comme de raison".

"Si mon mari avait été de mon dire, on en aurait pas eu tant d'enfants (12). On aurait pu modérer ça. Quand bien même que c'était péché je l'aurais fait pareil. On en faisait d'autre péchés pis on ne s'en occupait pas. Les hommes ça sacraient pis ça buvaient, c'était péché ça. Les hommes, c'est pas pour l'amour de l'église qu'ils faisaient des p'tits à tous les ans. Un homme se mariait pis y'avait tous ses droits. Y pensait à contenter son corps à lui, puis c'était tout. La plupart des hommes étaient comme ça, pis avec ça, ils étaient dans la loi, l'éclise les encourageaient."

ROOK REVIEW

The Double Ghetto: Canadian Women and their segregated work. Pat Armstrong E Hugh Armstrong.

We tend to look to books for answers-here's one which raises some questions about inequality btween the sexes. As their spouses' earnings increase, do more women stay at home because they no longer need to work, and prefer to be dependent on their husbands, OR are there more men as top executives because they have had traditional stay-at-home wives to do double parent and household duties and to carry the major burden of civic responsibilities? Would equal pay for work of equal value just mean higher paid job ghettos that are still menial and repetitive? Is it that women's work in the home limits their time, energy and commitment to work outside, OR is it that women's housework only provides them with skills and experience that are transferable to low paid and low status jobs in the wrokforce?

Women's participation in the labour forcevaries directly with the presence and ages of children in the home: is this because childrening is a woman's responsibility OR is it because of social stigma, the high cost of daycare and the fact that women have little to gain financially by working if all they can find is low paid work? Are women paid low wages because of plentiful supply of willing workers, or because their jobs are low status and low skilled, or because of prejudice against women, OR because their work is essential to the maintenance of labour-intensive manufacturing and service sectors where low wages are an economic reality?

Do children learn stereotyped roles in schools with female elementary teachers, higher paid male high school teachers and male principals OR do they learn it in the home by being assigned sex-specific tasks and by accepting stereotyped parental roles?

If you can't find it elsewhere, beg, borrow, or steal it from Marylou - that's how I got to read it! Definitely a book to consider.

FLASH! FLASH! FLASH! FLASH! FLASH! FLASH! FLASH!

Do you realize that women's rights may soon be set back CENTURIES?? Do you realize that women might be forced to return to the dark ages of backroom butcher abortionists?

THIS IS NO IDLE THREAT. If Joe Borowski is successful in his legal case, in which he argues that the fetus has the right to life under the Charter of Rights, there will be NO abortion available whatsoever. Not only will this end the availability in the present limited sense: if this case is successful, no woman or girl can terminate a pregnancy, ever. Even if the girl is 11 years of age and a rape victim. Even if the woman is 50 years of age with all her family grown. NEVER.

The Sudbury Women's Centre is launching the "PRO-CHOICE DEFENCE FUND", and we will be raising money to defend those arrested at Morgentaler's Clinics, to fight Borowski, and to fund our own law case in which we claim that women have the <u>right</u> to an abortion under our Charter of Rights, because of the right to "liberty of the person" (this case was recently begun by the Canadian Abortion Rights Action League, of which we are members).

We will also be sponsoring educationals on the right to choice. We plan a forum in September or October, in which the insidious implications of the Borowski case will be explained, and where we will hear about C.A.R.A.L.'s case.

As you may know, the Women's Centre is the information line for the Rape Crisis Centre, so we thought we would bring you up to date as to goings on in the Rape Crisis Centre.

Things have really picked up since we hired our staff person, Sheila Kelly, in February. Sheila has spoken to several groups of high-school students, groups of employees and, as well has appeared on phone-in radio and television programs. Future engagements include the Sudbury & District Health Unit and hospitals on Manitoulin Island.

A representative of the Rape Crisis Centre has been involved in an interagency committe which is looking into improved treatment for incest victims in the Sudbury area. The Rape Crisis Centre has also been asked to participate on the Sudbury Board of Ed.'s Health Curriculum Committee which will be looking into changes in the present health curriculum.

At the present time, the Rape Crisis Centre is looking into the possibility of having an "Acquaintance Rape Prevention Series" taught at the Women's Centre and we are co-sponsoring, along with the Women's Centre, a Pornography Workshop which is set for September. We have also been taking action, whenever possbile, in regards to events in Sudbury.

You may recall that recently a 19 year old man received a 5 year sentence for brutally raping a 57 year old Onaping Falls Woman (the Judge felt that the sentence shouldn't be too harsh because of his "youth"). The Rape Crisis Centre wrote to the Crown Attorney requesting an appeal for a harsher sentence. This appeal has been launched.

We also wrote the Executive Director of the Sudbury General Hospital in regards to a copy of a letter we received from a Sudbury woman who complained of overhearing a rape examination while she was in the Emergency Dept. We stressed the need for more suitable facilities for sexual assault victims.

Welcome to a new volunteer who has joined our ranks. The Rape Crisis Centre is always in need of new volunteers. If you are interested in becoming involved, either as a counsellor or as a public educator (speaker, writer, etc..) phone Sheila or Marylou at the Women's Centre.

MEDIAWATCH

Last month's newsletter stressed the importance of SPEAKING LOUDLY against ads. which are offensive to women, and the Mediawtch Committee can attest to that. We encourage all members to monitor local media and to bring offensive media portrayal of women to our attention.

We recently complained about an ad used by the Outdoorsman, which showed a cartoon figure of a woman whose breasts were falling out of a tight leather vest (will someone please explain what this has to do with canoes?).

This ad. was replaced with a very inoffensive cartoon of a man (but of course, he was not wearing a leather G-string!)

One of our members also complained about a matchbook in a local restaurant which read "if your wife can't cook, don't divorce her, bring her to our restaurant". The restaurant in question has received a letter from the Advertising Advisory Council.

During the summer of '83 the issue of "spouse battering" is being addressed in an attempt to initiate a treatment program for those who batter their spouses. The objective of this research is to design a treatment program to be presented to Family and Criminal Court judges, as well as to Probatin & Aftercare, as part of the Offenders Probation Order.

However, the project is merely a feasability study at this point in time. At present, an attempt is being made to evaluate the extent of this crime within our community.

Consider these alarming facts: on March 8, 1981, the day after International Women's Day, the Toronto Sun's headline read "Fems Embrace Gays"; "Women Alive", an Alberta-based evangelical group, propounds that "women can find a purpose in life only through God and submission to their husband and the Canadian Klan has more than 500 card-carrying members and 200 subscribers to the Crusader.

With the daily worsening of our economic crisis, mor and more extreme right-wing groups are forming rapidly, and thanks to the lessons learned from the left during the 60's, these forces have achieved a definite influence in the political sphere of Canada.

As women, we must be aware of the threat posed by right-wing forces: the New Right centres its appeal on emotional social issues, and at the fore-front is their claim that a return to traditional, family-oriented issues will cure the country's economic ills.

The New Right uses the romantic ideal of the happy, father-dominated household as a parallel to justify the demand for civil obedience and stronger government control.

It was largely due to the work of Phyllis Schlafly, the New Right's "Total Woman" that the Equal Rights Amendment was defeated in the U.S.

It seems that good ole' Phyllis fears that "equality for all" means that she will have to use unisex washrooms, work in coal mines, and use the men's locker room (at the Golden Door Spa in Los Angeles, no less). On feminism, Phyllis cries, "Man-haters, all of them!" On abortion, Phyllis cries "Murder!" No doubt Phyllis has close ties with the Great White Norths Joe Borowski.

The New Right is a very real threat to the gains made possible by the women's movement: daycare, reproductive rights, equal pay for work of equal value, freedom from sexual assault are all targets for right-wing supporters

As women united, we can no longer accept this attack on our rights and freedoms, and we can no longer sit idly while the attack mounts fiercer.

from McCall's magazine, Shirley Streshinsky, on the not-so-weaker sex:

"Somewhere before the first grade, children pick up the conviction that males are stronger than females. But recent studies show that girls and boys are equally matched in physical ability until aged 10 to 13. Male strength continues to increase after that, while the female's peaks at age 15... but the potential for women to increase their strength is enormousperhaps one of their greatest untapped resources. When women stop being dependent on men to do the physically hard tasks of life, their own lives can move forward. They are not forever waiting for someone to lift the big box or free the jammed garage door."

EDITOR'S NOTE; Ms. Strshinsky has a point. I recently started lifting weights, and I am just now starting to know the meaning of physical strength... and power. What I don't like though, is that, like every other "male domain" women enter, they are valued on different grounds. The appeal for women to lift weights now seems aimed at building a beautiful body,

i.e. one that men and other women admire. At the same time, we seem to be defining a new concept of beauty: strong, muscular women with tight derrières and shapely legs. And so now, all the women who have been starving themselves to look petite and fragile will start "building their bodies"... until "someone" tells us that strong muscular women are passé.

NATIONAL ACTION COMMITTE

NAC is requesting that each & every woman send a telgram to the Minister of Indian Affairs, demanding immediate legislation to:

- 1) Reinstate all native women who have involuntarily lost their Indian status under the operation of the Indian Act, and
- 2) Register the first generation children of these women.

URGENT ACTION is needed on this, as Cabinet is presently addressing the matter.
